Mayor's Message

TOWN HALL MEETING

January 27, 2018

The 8th Annual Town Hall Meeting was held on Saturday, January 27th, 2018. The meeting was attended by citizens, city council and staff and was facilitated by UTSA professor, Dr. Francine Romero. Approximately 100 Leon Valley citizens turned out to express their views on the issues presented.

We began the meeting by summarizing what was discussed and achieved after the 2017 Town Hall: we passed a home rule charter, completed the city's Master Plan, and implemented a red light camera system primarily along Bandera Road. At the January, 2017 meeting, we also discussed use of the 1/8 cent sales tax for economic and community development projects, and the planned Hike and Bike trail route from Shadow Mist (Crystal Hills Park) under the bridge to the Huebner -Onion Homestead.

Following this review, presentations were made on the new solid waste contract, the City's On-It program and how it works (online or phone in to report code and other citizen concerns), and the benefits of Home Rule status.

Next, the citizens discussed and

voted on the following topics to give direction to council/staff on how to proceed.

Topic 1: 2018 Leon Valley Swimming Season. Raymond Diaz, Chairman of the Pool Advisory Committee, presented recommendations on management of the two city-owned pools at Forest Oaks and Peachtree/Poss. Last year, a private company, Sela Aquatics, operated the two pools. After hearing evidence, citizens were polled on whether they favored continuing with Sela (64% yes; 36% -no); and more food concession options (80% - yes; 20% - no). Increasing advertising and signage about the two city pools was also stressed to increase participation from the community and to support additional programs at the pools (91% - yes, 9% - no). It was recommended that in light of citizen comments, the Pool Advisory Committee revise their recommendations and bring them back to council for action.

Topic 2: Potential uses of the Peachtree/Poss vacant lot. In 2017, the Park Commission recommended and council approved the building of a pavilion at this site, adjacent to the city pool. Nearby residents then expressed their strong opposition. A De-



cember, 2017 workshop was held, and the consensus was to bring this issue to the town hall meeting. Choices presented at the town hall meeting, besides a pavilion, included remodeling the existing pool facility, beautification of the site, a community garden, and "Other". "Other" was rated highest at 49% when polled by the participants. Another recommendation was to accommodate food booths. bounce houses, and artwork, on holidays or other high- use times. The Park Commission will consider all the options and make recommendations to city council. The council will also consider in March whether to withdraw the option of putting a pavilion on the lot, due to citizen opposition to the pavilion.

Topic 3: Bandera Road Options.Representatives from UTSA

Planning presented a "Visual and **Economic Analysis of Alternatives** for Bandera Road". They presented the idea of a "boulevard" as an alternative to an elevated roadway. (The latter is TXDOT's current long term proposal). The projected economic impact of an elevated roadway would create a significant reduction in property values according to the UTSA representatives. A visual citizen preference poll was taken and the results were: Do Nothing (0%); Elevated freeway with two additional lands at ground level (7%); Boulevard/ multi-modal access (88%); and None of the Above (5%). Some participants were concerned that the choices given were too restrictive and wanted more options. Others asked to develop a timeline for decision- making, and for more public meetings where this dialogue can continue. One of the recommendations was that the Mayor and City Manager continue to collaborate with TXDOT, the City of San Antonio, State Representative Justin Rodriguez' office, and the Metropolitan Planning Organization (on which I sit) to determine whether this boulevard option can work within the parameters of the corridor. UTSA's boulevard concept is a start, but engineering and funding must be obtained if this is the preferred way forward.

Our final topic: Updating the City's Strategic Goals from 2014.

The input from citizens on eight goals will be discussed at the Coffee with the Mayor and Council on Saturday, April 28, 2018, 9 – 11 a.m. at the Conference Center.

Leon Valley Photographic Traffic Control System

After much community input and citizen direction throughout 2017, the red-light cameras are up and running in Leon Valley. The warning citation period started on January 20th and the citations with fines

attached began on February 21st. The fine amounts are set by the Texas Legislature at \$75 per incident, and a \$25 late fee if not paid on time. Our staff continues to remain open and transparent with the community, giving a multitude of interviews and press releases on social media over the last few months. The reason is because it is important for everyone to know they are there so that improper driver behavior decreases and our goal of a safer commute through

Leon Valley is met. We want a safer Leon Valley for drivers, pedestrians, mass transit and bicyclists. These cameras are about changing poor driving habits that result in numerous accidents and injuries each day. Approximately 93% of vehicle accidents don't involve Leon Valley residents, meaning that resident's taxpayer dollars are going to pay for the poor driving habits of those outside of this community. Continually working traffic accidents along Bandera Road inhibits our ability to respond to citizen's complaints or focus on neighborhoods that need more frequent patrol. With that said, let's try and dispel some of the fear of red-light cameras:

• If someone gets a citation in my car, do I have to pay the fine?

No, but you will be required to provide an affidavit stating the name of the person who was driving.

• If I sell the car, and someone gets a ticket, will have to pay the fine?

No, but you will be required to provide documentation as to the sale of the vehicle.

• Citations will be given if you just inch over the line at the intersection?

No, we have established parameters as to what constitutes a violation and stopping just past the line is not a violation that a ticket will be issued for at this time.

• If this is a civil fine, then I don't have to pay it, right?

Not true either. If the driver doesn't pay the fee, they will be restricted from getting their license and registration.

Winter Sewer Averaging for Leon Valley Water Customers

Sewer charges for residential customers are based on a winter sewer average. The average water consumption used during the winter months of November 15 - February 15 each year determines your monthly sewer charge for the next twelve months. The new winter average goes into effect on the March billing each year. Should you have a water leak during this period, you may request a Sewer Adjustment Form from the Utility Billing office. Forms must be received no later than May 1st for consideration.

Please be reminded that April 5, 2018 is the last day for unregistered applicants to submit a federal postcard application.

You are welcome to contact the City Secretary (210) 684-1391 extension 216 for assistance with voter registration or any other questions you may have.

Voting by mail has been available to elderly voters and voters with physical disabilities in Texas for decades. Applications for a ballot by mail must be submitted to the Bexar County Elections Department no earlier than 2 months before Election Day and no later than 9 days before.

You may vote by mail if you are:

- · Going to be away from your county on Election Day and during early voting
- Sick or disabled
- 65 years of age or older on Election Day
- Confined in jail, but eligible to vote

Please complete and return your application between 60 days and 9 days prior to the election for which a ballot is requested. Applications are available at City Hall or for further information, please call (210) 335-0362.

Bexar County Elections Department must receive your marked ballot by 7 p.m. on Election Day.


