RESOLUTION NO. 12-004

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS, CANVASSING ELECTION RETURNS OF THE JOINT GENERAL AND SPECIAL ELECTION HELD IN CONJUNCTION WITH BEXAR COUNTY ON MAY 12, 2012, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO CITY COUNCILMEMBERS, AT LARGE, FOR THE CITY COUNCIL, ONE MAYOR, ONE CITY COUNCILMEMBER PLACE NO. 2, AND ONE CITY COUNCILMEMBER PLACE NO. 4, AND DECLARING ELECTED CITY COUNCILMEMBERS IN COUNCIL PLACES: MAYOR, COUNCIL PLACE NOS. 2, AND 4; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 12, 2012, in accordance with the relevant provisions of the Texas Election Code and the City of Leon Valley Code of Ordinances, the general (regular) municipal election was held for the purpose of electing one Mayor, one City Councilmember in Place No. 2, and one City Councilmember in Place No. 4; and

WHEREAS, the City Council ordered a General Election in the City of Leon Valley to be held on May 12, 2012, Jointly with Bexar County for the Purpose of Electing City Councilmembers in the Mayor's Place, and in Place Nos. 2, and 4 by the qualified voters of the City of Leon Valley and authorized the City Manager to contract with the Bexar County Elections Administrator for the conduct of said election; and

WHEREAS, the City Secretary and Bexar County Elections Administrator have administered all matters pertaining to the conduct of said election; and

WHEREAS, the election officers who held said elections have duly made the returns of the results thereof; and

WHEREAS, the Mayor Pro Tem by his signature hereon concurs with the results of the election as determined by the election officers holding said election and herein declared;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS:

Section 1. That the Mayor and City Council officially find and determine that said elections were duly ordered, that proper notice of said elections was duly given, that proper election officers were duly appointed prior to said elections, that said elections were duly held, that due returns of the results of said elections have been made and delivered, and that the Mayor and City Council have duly canvassed said returns, all in accordance with law.

Section 2. That the Mayor and City Council officially find and determine that every person attaining the age of eighteen (18) years and having resided within the limits of the City of Leon Valley for thirty (30) days next preceding the date above fixed for said election and who was a qualified voter under the laws of the State of Texas was permitted to vote at said elections for the candidates for which they were entitled to vote, therefore, to wit:

Section 3. That the Mayor and City Council hereby officially find, determine and declare the results of said election to be as follows:

Mayor – Chris Riley received a majority of the votes cast in said election and is hereby declared elected as Mayor.

City Councilmember Place No. 2 – Athur "Art" Reyna, Jr., unopposed, received a majority of the votes cast in said election and is hereby declared elected as City Councilmember Place No. 2.

City Councilmember Place No. 4 – Jack Dean received a majority of the votes cast in said election and is hereby declared elected as City Councilmember Place No. 4.

Section 4. That this resolution shall be effective immediately upon adoption.
