SIGN PERMIT APPLICATION

INFORMATION FOR COMPLETING SIGN PERMIT APPLICATION

- A copy of the sections of the guidelines related to permanent signs is attached to this application. You may also request a copy of the ordinance.
- This application must be submitted and approved before sign installation. Failure to secure a permit will constitute a violation of Chapter 3.04.
- The fee for each permanent (non-electric) sign is \$100.00; if the sign is illuminated, the fee is **\$150.00**.
- Applicant (as designated by the authorization letter) is required to call the Community Development Department to request an inspection once sign installation is complete.
- Electrically illuminated signs must be installed by an electrician who is licensed in the City of Leon Valley. A separate electrical permit is not required.
- Multi-tenant centers **OR** single-tenant properties with over 300 feet of street frontage, at least 30,000 square feet, or land area of at least 5 acres are strongly urged to apply for a Master Sign Plan.
- If there are existing signs on the property, applicant must complete **Attachment B – Existing Signs**.
- Application review takes an average of 3-5 working days. You will be notified when your application has been reviewed.
- **Incomplete applications will not be processed.** All items must be provided when you first submit your application. See attached checklist for list of items which must be submitted.
- During the review process by the City Inspector, may request additional information.

_____ **LOCATION/SITE PLAN** - to accurate scale, showing the exact location of proposed sign, relation to buildings, streets, easements and utilities.
