


**GENERAL FUND**

**SUBJECT: REQUEST TO AUTHORIZE THE CITY MANAGER TO RENEW THE EXISTING INDEPENDENT CONTRACTOR AGREEMENT FOR GRANT WRITING SERVICES AND TO APPROVE ASSOCIATED BUDGET ADJUSTMENT NOT TO EXCEED \$25,000.**

**PURPOSE**

To authorize the City Manager to renew the existing independent contractor agreement for grant writing services with Kathryn Word for another six months and to approve expenditure of funds to pay for those services from the FY 2010 Budget - Manager/Council General Fund account reserved for economic development uses as approved by the City Council.

This contract will last until the end of April 2010. Continued use of grant writing services will be dependent on the ability of the grant writer to obtain funding that will pay for the service fees and funding for City projects.


**FISCAL IMPACT**
