


2. This ordinance shall become effective on and after it's passage, approval and any publication, as provided by law.

PURPOSE

To authorize a budget adjustment of \$500.00 to allow Trade and Market Day (TMD) Sponsorship monies collected in FY2009 to be used in FY2010.

The City of Leon Valley received several sponsorships equal to \$500.00 from local businesses, specifically the Mustang Auto Club and Geraghty Tennis, in support of this community event in the Spring and Summer of FY2009. These Sponsorship monies were not able to be used in FY2009 and now are needed to enhance the events for FY2010.

Economic Development – Use of the sponsorship monies will improve the TMD events to attract more visitors to the area which will enhance City business exposure and economic development.


