

AN ORDINANCE

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS, REPEALING AND REPLACING SECTION A2.003 “MUNICIPAL PARK ADMINISTRATIVE FEES” OF ARTICLE A2.000 “ADMINISTRATIVE FEES,” OF APPENDIX A “FEE SCHEDULE” OF THE LEON VALLEY CODE OF ORDINANCES”, WITH A NEW SECTION A2.003 “MUNICIPAL PARK ADMINISTRATIVE FEES”

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS THAT:

1. The Leon Valley Code of Ordinances, Appendix A “Fee Schedule,” Article A2.000 “Administrative Fees,” Section A2.003 “Municipal park administrative fees” is hereafter repealed and replaced to read as follows:

“Sec. A2.003 Municipal park administrative fees

(a) All fees must be paid at the time of filing a reservation.

(b) Large Pavilion rental fees on Mondays, Tuesdays, Wednesdays, and Thursdays, will be as follows:

(c) Large Pavilion rental fees on Fridays, Saturdays, and Sundays will be as follows:

(d) BBQ pit may be rented only when pavilion is rented. Deposits are refundable if facilities

are left in satisfactory condition following use and pit keys are returned as per the contract.

(e) Other fees for rental of small pavilion, soccer fields, softball field, tennis courts, and volleyball pit:

Tennis Court	\$5.00/hour	Plus Non Refundable Application Fee of \$35.00*
*Multiple hourly field/pit/court rentals per applicant may be applied on one application at initial reservation filing.		

Reservations must be for a one-hour minimum with a three-hour maximum, in one-half-hour increments. The maximum and minimum times can be waived for league and tournament play.

(f) Non-refundable fees for large group clean up will be as follows in conjunction with any park facility rental:

For 50-100 persons	\$50.00 daily
For 101-150 persons	\$100.00 daily
For 151-200 persons	\$150.00 daily

2. Severability

If any provision of this section is illegal, invalid, or unenforceable under present or future laws effective during the term of this section then and in that event, the remainder of this section shall not be affected thereby, and that in lieu of each provision that is illegal, invalid or unenforceable, there be added as a part of this section a provision as similar terms to such illegal, invalid or unenforceable provision as may be possible and be legal, valid and enforceable.

3. This ordinance shall become effective on and after its passage, approval and publication as prescribed by law.
