Human Resources

- Positions being advertised for October 1, 2017:

Public Works

- Wrought iron fence for Huebner gravesite is in the process of being constructed at Cooper's Forge. Once constructed, it will be installed, along with the historical signage.
- The Evers Road sidewalk project is completed. The final walk through was conducted and final payment will be issued.
- Met with contractor for the new traffic signal system at Huebner and Evers. Mast arms and poles are expected to take 13 14 weeks for delivery. The contract has been executed. Continuing to work with CPS to coordinate site work.
- Contractor for the LID parking lot at City Hall has installed the pavers. The asphalt parking lot was completed this week.
- A new section was added under the Public Works web site page entitled, Understanding Your Water Bill. Each part of the water bill identified and a description is provided, in an effort to help our customers.
- Huebner at Timberhill CDBG project is in progress. The drainage inlet work is complete, and the sidewalks and asphalt phase is underway.
- The Solid Waste Management RFP is currently being advertised.
- Submitted an AACOG Solid Waste grant this week.
- Met with Bexar County CDBG and the contractor for a pre-construction meeting for the Conestoga Water/Sewer Main Replacement Project. Construction will begin in two weeks.
- Working with engineer on Evers Road bridge project. 100% plans were submitted to TxDOT, and we received TXDOT approval. The bid will be prepared and advertised with construction scheduled to start in November.

- Still receiving quotes for various repairs at the Forest Oaks pool facility, a majority of the electrical work has been performed. The City Engineer is working on plans to repair the retaining wall and pool deck.
- Working with contractor for LC-17 to keep residents informed of progress.
- The Don't Block the Box campaign has been delayed, pending tentative approval from TxDOT.
- Exploring ideas for new Veteran's Park at Community/Conference Center grounds will be constructing a fire pit for flag burning ceremonies.
- The Cades Cove Water and Sewer Main replacement project has been recommended for funding in the amount of \$270,149. The project is being engineered.

- Code Compliance and Animal Control
 - Code Enforcement Officers continue to work with a resident in the 6800 block of Forest Meadow on a long standing problem of junk vehicles and hoarding of trash. The home owner had two garage sales this weekend and any other items not removed will be taken away and the illegal structure in front of the house will be removed this week.
 - Animal Control Officers made 28 animal related calls for service over this time period. The
 officers picked up 16 dogs, 3 cats and one bird. All of the animals were released to their owners
 or adopted out through adoption agencies. In addition, the officers picked up 10 dead animals, to
 include one dog, one cat, two raccoons, one skunk, and five deer.
 - Code Compliance officers responded to 77 code related calls over this time period. The focus during this period was on high weeds and junk vehicles. During this time period 26 residents were notified about clearing their yards of high weeds, and 38 residents were notified about junk vehicles in their yards. Four vehicles were towed from non-compliance. There were also six calls for trash and debris pickup.

- All officers received training on, and qualified with the newly issued personal protection bags and training on the medical bags that were recently purchased.
- Conducted Roll Call Training for all Officers on Proper Means of Documenting and Processing Forgeries.
- Community Services
 - Ten LVPD officers participated at Boots and Badges event at Whataburger on Bandera Road. The Officers were joined by officers that the department invited from San Antonio Police Department, Bexar County Sheriff's Office, and the Texas Department of Public Safety.
 - The Leon Valley Police Department had two days of successful National Night Out events in Leon Valley. The Mayor, Council Members, City Manager Kuenstler, and Asst. City Manager Caldera joined with numerous LVPD officers and LVFD firemen in visiting sixteen (16) neighborhood events throughout the City.
 - The Leon Valley Police and Fire Departments joined together to raise money for Special Olympics at the Annual Fire Truck Pull . The team completed the 75 foot fire truck pull in 16 seconds, finishing in the top of the group and represented Leon Valley very well.

Fire Department

- **Fire Prevention Month** The Fire Department is actively engaged in fire prevention activities throughout the community the entire month of October. Activities this week included two full days at Leon Valley Elementary school teaching fundamentals of fire safety including; Stop, Drop and Roll when clothes catch fire, building a plan with your family, checking smoke detectors, and more...The event closed with a presentation of awards to the annual poster contest winners, including a new bike! Prizes were donated by local businesses; Pena Brothers upholstery, Woolf Sheds, Leon Valley Skate Center, Leon Valley Bowl, Dairy Queen, and more!
- Even more Fire hydrants painted! Scouts from Troop 911 and Pack 484 spent a day painting all the fire hydrants at the Shadow Mist and The Ridge subdivisions. The Scouts earned merit awards with their work while learning citizenship and beautifying their community.
- **Flu shots** The Fire Department is administering free flu shots to all city employees. Flu shots are made available on a voluntary basis to employees, and are intended to prevent an outbreak in the workplace. The City of Leon Valley's Medical Director, Dr. Manifold, is encouraging all citizens to seek opportunities to obtain a flu shot.
- **Fitness** Leon Valley Firefighters competed in a regional fitness challenge on October 7th and took 2nd place out of 10 teams of regional First Responders. Leon Valley Firefighters will be competing in Pearsall, Texas in another fitness challenge on October 13th, and defending their title! Leon Valley firefighters continue to seek opportunities to improve fitness and teamwork.
- **Breast Cancer Awareness month** Leon Valley Firefighters are selling Breast Cancer Awareness tshirts through the month of October. The shirts are grey and pink this year and are \$15 each. Community Development Department

- Staff has completed the proposed Master Plan, with the exception of revising the maps. The maps are being edited and the document formatted to place on the web site for public viewing.
- Staff met with Emil Moncivais on Oct. 10, 2017 to review consultant's recommendations related to zoning code revisions. Staff presented a power point presentation on the consultant's recommendation

to the Zoning Commission on September 28, 2017. Staff will bring code amendments to Zoning Commission in January, 2018.

- Zoning Cases
 - SUP 2017-282: Specific Use Permit request for a proposed microbrewery and pub (Timco West) is scheduled for the October 24, 2017, Zoning Commission meeting and November 7, 2017 City Council meeting.
 - SUP 2017-280: Specific Use Permit request for a dog kennel to be located near the corner of Grissom and Poss Roads was recommended for approved by the Zoning Commission on September 28, 2017 and was approved by City Council on October 2, 2017.
 - SUP 2017-281: Specific Use Permit request for Entertainment Outdoor for 6320 Bandera Road was postponed at the September 28, 2017 Zoning Commission meeting due to an incomplete application submittal.
 - Staff received an inquiry for a Specific Use Permit for a proposed veterinary clinic at the corner of Poss and Grissom. Staff researched and compiled development history for this property.
- Case 2017-215 Board approved a variance to the sign provisions of the Zoning Code for a developer of a convenience store (Quick Trip) located at 6461 Bandera Road on (9/28/17)
- Potential case to request a variance for a side yard encroachment at 6003 Forest Bend for November, 2017. Not application received to date.
- Replat 2017-002 Crystal Lake: Proposed plat will consolidate parcels for a business park on 5309 Wurzbach Road.
- 5 Certificates of Occupancy and 49 construction permits were issued from October 2-12, 2017.
- Staff submitted a proposal to Texas Parks and Wildlife for a Small Cities grant to fund a pavilion at the Triangle Park area for \$92,000 (50% match) on October 1, 2017.
- Staff is finalizing "Adopt a Spots" in Raymond Rimkus Park and will begin outreach to businesses and community organizations.

- The library now offers Homework Help every Thursday from 4:30 5:30 pm with Dr. Catherine Rodriguez helping the students.
