### PUBLIC WORKS

- Huge thanks to Officer Sanchez of the Police Department for her assistance with the Basura Bash event. Due to her efforts with the homeless encampment, four large truckfuls of debris were filled with debris from Zarzamora Creek – the most ever picked up! Also deserving a round of applause was the Boy Scout Troop 71 – they also filled a truck with debris.
- The engineer will start work on designing the El Verde Water Main Project.
- The engineer is in the design phase for the Hike & Bike Trail Segment II.
- Staff is working on an Impact Fee Study and water and sewer rate study.
- The sewer televising and cleaning contractor continue their work.
- Plans for the FY 2024 Street Maintenance Project are underway. The targeted neighborhood is Grass Valley.
- Engineering and design are underway for the second portion of the Wurzbach Sewer Main Replacement Project.
- Working on repairs to the Kinman House – the foundation is sinking on the Forest Pine side of the structure.

- Working on repairs to the Sally Port at the Police Station – the frame has been water-damaged and needs to be replaced.
- Working on the Fire Station overhead doors and door frames to repair functionality.
- Preparing for replacement of storefront area at City Hall near Council Chambers.
- Preparing for remodeling of the Conference Center to install a kitchen area.
- Repairing asphalt at 7101 Bandera Road.
- Repairing pothole at Forest Oaks Pool parking lot.
- Completing service requests from water utility repairs.
- Restoring pavement along a sewer easement at 6312 Grissom Road.
- Attending class in operation of new crackseal trailer.
- Rebuilding water sheds at Fire Station.
- Restoring fencing at Shadow Mist Park. Reading meters.
- Videoing sewer main on Strawflower to locate service line for customer.
- Installing water valve in Linkwood to assist in future emergency shut offs.
- Replacing dead meters.
- Performing meter and service line inventory per the TCEQ.

### **FIRE DEPARTMENT**

- High Sierra is on-site doing a complete assessment and repair of the Halt Gate system. Currently, the flood sensors are not working and are sending false alarms. The servers that run the local system have been moved from the Police Department offices to the Fire Department. The FD and PW are waiting for the assessment and quotes for the needed repairs to the HALT system. Once this is received, we will develop a plan for all needed repairs. The movement of the flood siren system is still pending.
- The Fire Department hosted “Fire Chief of the Day.” This program is through the Driggers Elementary School PTA and was auctioned off as a fundraiser item. The winning student was Paeton Beasley. This 4-year-old student, along with her parents, was picked up at school and driven back to the fire station for a guided tour and inspection of all fire vehicles, along with demonstrations of our ladder truck and EMS units. Paeton and her parents were given a ride in our fire engine back to Driggers at the end of the tour.



- The Fire Department will begin scheduling Stop the Bleed classes for all City employees beginning 02/19/2024. These classes will be taught in the FD training room and will be in groups of 5. This will allow all employees sufficient time to practice the needed skills. Coordination for these classes will be through AFC Willis.
- The Fire Department completed 192 hours of continuing education training in fire and EMS during this 14-day reporting period.
- The Fire Department received a perfect score on their TCFP inspection.
