**SUBJECT:** Pre-City Council Meeting Report

#### **Projects**

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

#### **PUBLIC WORKS**

- The City Engineer has completed plans for the replacement of water mains on Pickering, Rimkus, and Kinman. Bids for this project were advertised and reviewed. The item will go to City Council for award on October 21st.
- The City Engineer has completed plans for replacing sewer mains on Forest Brook, Forest Ridge, Forest Mill, and Forest Knoll (2,700 +/- linear feet). Bids were advertised and will be opened this week.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road and along Aids Drive.
- We will be installing a traffic warning sign on Evers at Adair.

#### **Additional Public Works Activities**

- Performing a mill & overlay on 184' of trail at Silo Park.
- Repairing asphalt on Poss Rd.
- Cleaning out debris from Huebner Creek.
- Replacing hand dryers at Raymond Rimkus Park restrooms.
- Reshaping/sanding volleyball court at Raymond Rimkus Park.
- Cleaning out dead trees and debris from Huebner-Onion Natural Area Park.
- Flushing dead end mains.
- Taking water samples.
- Replacing bad valves on Poss and on Huebner Road.
- Setting new water service on Stebbins.
- Repairing leak in Raymond Rimkus Park.
- Continuing dead meter replacements.
- Addressing service requests for leaks.
- Repairing lawnmower.
- Repairing hose leak and bearings on street sweeper.

- Getting quotes for new equipment.
- Assisting with auction.
- Repairing car wash.
- Replacing fuel pump on loader.
- Repairing asphalt on Caraway Bend from two street failures at manholes
- Continuing pickup of excess brush piles city-wide. Last year we had approximately 34 piles and this year we are topping 80 piles, so it's going slower than expected. This has been completed.
- Continuing to mow Zone 1.
- Repairing lock on Community Center door.
- Repairing sprinklers in Raymond Rimkus Park.
- Installed new water service in Monte Robles Park.
- Repairing two lawnmowers.
- Repairing chipper.
- Performing end of month and end of year reconciliation.
- Performing a mill & overlay on the trail at Raymond Rimkus Park.
- Repairing asphalt on Caraway Bend from two street failures at manholes.
- Trimming trees and vegetation behind Red Jacket.
- Repairing sprinklers at Veteran's Park.
- Installing "No Dog Dumping" signs.
- Repairing Public Works automatic gate
- Replacing sign in Pavona Place.
- Preparing for asphalt on Stebbins from street cut.
- Mowing on Evers and on Aids Drive.
- Cleaning out creek behind Public Works
- Repairing main breaks on Stirrup and on Cades Cove.
- Installing new meters at Grissom Road car wash.
- Taking water samples.
- Repairing lawnmowers.
- Repairing street sweeper.

#### **PW Grants**

- The El Verde Water Main Replacement Project is being funded with a \$1,300,000 Bexar County ARPA grant. Bids were advertised and this item will be taken to City Council on October 21st.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project was advertised, and bids were reviewed. The item will go to City Council for award on October 21st.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We have submitted 100% plans for review. Letting the project for bids is expected in November of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary for about three years. The Forester would be used to monitor Oak wilt disease, review tree removal requests, assure tree permits are being inspected, determine the condition of city trees in various parks, and make recommendations for removal or replacement of trees.

- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff was awarded a grant in the amount of \$590,423 from Bexar County CDBG to install a new sewer main along Locker Lane. Plans are being developed for the project.
- Staff applied for a 50/50 matching grant to rehabilitate the Forest Oaks Community Pool. Grant awards are not expected until January 2026.

  and candles do not mix well. Please remember that the LVFD is always willing to help
  change smoke detector batteries for residents who need assistance. Please contact us, and
  we will schedule an appointment.
- Please be mindful of the children and some adults out on Halloween night. Drivers should pay special attention when driving in the neighborhood, as children might jump into the street anywhere. These kids might be hard to see in dark colored customs.
- Fall seems to be the beginning of our most needy time of the year. Many families and individuals we encounter may not have enough food, baby formula, diapers and warm blankets. The Fire Department needs non-perishable food, dry goods, diapers and baby formulas to replenish our Community Care Box. Please donate what you can and if you are in need, we are here to help.
- As we enter fall, remember, low-hanging trees over the road can impede emergency
  responders and damage emergency vehicles, causing thousands of dollars in damage. Trees
  tend to hang even lower during rain. The current city ordinance requires trees hanging over
  the road to have a clearance of 14 feet. Help our department ensure that responding
  emergency vehicles can safely travel our street.
- The Fire Department would like to remind residents that in the event of an emergency, all emergency responders must be able to see your address in front of your residence. These numbers should be a contrasting color to the background and large to be easily seen from the road. If you can, turn on your outside/porch light.
- The Fire Department would like to thank all the residents who hosted National Night Events in the neighborhoods. It was great to meet new people and see old friends.
