SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- Staff presented the Capital Improvements Plan to the City Council on October 19th. A
 short presentation was given in November on potential funding from the Texas Water
 Development Board and EPA. This item was presented to the Town Hall meeting
 participants on January 25th and will now go back to the City Council for a final
 decision on whether to increase water and sewer rates.
- The final draft of the Park Master Plan has been placed on the city website for 30 days to gather any last-minute input from the citizens, and it will be presented to the City Council for final approval on March 18th.
- The City Engineer is working on plans for the FY 25 Street Maintenance Project. This year we will tackle a portion of Wurzbach Road (Evers Rd. to Bandera Rd.).
- Staff is evaluating the water and sewer main priority list to determine which mains to replace as a project for this spring.
- Staff is finishing up the easement agreements for the right of way along William Rancher and along Aids Drive.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road.

Additional Public Works Activities

- Repairing trail at Raymond Rimkus Park. Replacing a section of asphalt trail this week.
- Repairing a long sidewalk along Forest Grove, and two other portions along Bridlepath and Sulky.
- Replacing traffic signs throughout the city.
- Mowing Mow Zone 3 (Grissom Rd area) this week.
- Cleaning out trash from Huebner-Onion Natural Area Park at Bandera Road bridge (behind Red Jacket).

- Removing kitchen cabinets at Fire Station in preparation for vent hood installation next week.
- Performing rereads on water.
- Repairing the sprinkler systems at Raymond Rimkus Park and at City Hall.
- Replacing the fire hydrant on Ellerby Point.
- Flushing dead-end mains.
- Performing inspections at Seneca Trails for sewer main installs.
- Fulfilling service requests from the Police Department vehicles.
- Performing maintenance on Public Works dump trucks and stake bed truck.
- Repairing an asphalt patch on Setting Sun.
- Mowed Mow Zone 1 (Evers/Huebner) and Mow Zone 2 (central part of City) last week.
- Mowing pocket parks.
- Removing trees and branches that were damaged from high winds.
- Replacing dead meters.
- Repaired the Fire Department sprinkler system, and Community Center area sprinkler heads.
- Coordinating with Third Coast Environmental for quarterly testing for volatile organic compounds (VOCs).
- Performing inspections at Seneca Trails for sewer main installs.

PW GRANTS

- The engineer continues designing the El Verde Water Main Replacement Project. This project is being funded with a \$1,300,000 Bexar County ARPA grant. The project will be advertised for bids in April.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- The City Engineer received direction from the City Council to follow a new alignment for the Huebner Creek Erosion Control Project and has redesigned it to follow the existing creek. Staff applied for a Texas Water Development Board (TWDB) Flood Infrastructure Fund (FIF) grant and a FEMA Flood Mitigation (FMA) grant for project funding.
- The CDBG East of Wurzbach Sewer Main Replacement Project, awarded to Texas Utilities, is starting their work this week.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II and have met with TxDOT for a review of the 30% engineering and design. We have submitted plans for environmental and bridge review. The trail is a part of a reimbursement grant from the Federal Highway Administration and TxDOT. Letting the project for bids is expected in October of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary
 for about three years. The Forester would be used to monitor Oak wilt disease, review
 tree removal requests, ensure tree permits are being inspected, determine the condition
 of city trees in various parks, and make recommendations for the removal or
 replacement of trees.
- Staff has applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared

- path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff is applying for a grant from Bexar County CDBG to install a new sewer main along Locker Lane. Property owners along this street have on-site sewage facilities (septic tanks) that are or have been failing due to age and several owners have asked the city if they could connect their properties to the city's wastewater system.


