SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- Staff presented the Capital Improvements Plan to the City Council on October 19th. A short presentation was given in November on potential funding from the Texas Water Development Board and EPA. This item was presented to the Town Hall meeting participants on January 25th. The City Council has approved the rate increase, and the ordinance will now be presented to City Council for final approval.
- The City Engineer is working on plans for the FY 25 Street Maintenance Project. This year, we will tackle a portion of Wurzbach Road (Evers Rd. to Bandera Rd.).
- Staff is evaluating the water and sewer main priority list to determine which mains to replace as a project for this spring.
- Staff is finishing up the easement agreements for the right of way along William Rancher and along Aids Drive.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road.

Additional Public Works Activities

- Installing a length of sidewalk along Horsetail at Stirrup Lane.
- Installing No Parking signs on Thistle.
- Replacing sidewalk on Forest Pine.
- Replacing traffic signs throughout the city.
- Mowing City Hall.
- Mowing Mow Zone 2 (Bandera Rd).
- Readying all parks for Easter weekend festivities.
- Trimming trees along Evers at Hodges, and on Thistle and Balky.
- Draining the Leon Valley Community Pool and removing all items from that facility.
- Addressing service requests.
- Reading meters.

- Mowing well sites.
- Performing inspections at Seneca Trails for water and sewer main installs.
- Fulfilling service requests from the Police Department vehicles.
- Performing preventative maintenance on backhoes and stake bed trucks.
- Repairing lawnmowers.
- Servicing Economic Development truck.

PW GRANTS

- The engineer continues designing the El Verde Water Main Replacement Project. This project is being funded with a \$1,300,000 Bexar County ARPA grant. The project will be advertised for bids in April.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- The CDBG East of Wurzbach Sewer Main Replacement Project, awarded to Texas Utilities, has started.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We have submitted 60% plans for review. Letting the project for bids is expected in October of 2025.
- Staff is applying for a grant to acquire the services of a Forester. The grant will pay a salary for about three years. The Forester would be used to monitor Oak wilt disease, review tree removal requests, assure tree permits are being inspected, determine the condition of city trees in various parks, and make recommendations for removal or replacement of trees.
- Staff has applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff applied for a grant from Bexar County CDBG to install a new sewer main along Locker Lane.

- Please remember that the LVFD is always willing to help change smoke detector batteries for residents who need assistance, please contact us and we will schedule an appointment.
- The Fire Department needs non-perishable food, dry goods, diapers and baby formulas to replenish our Community Care Box. Please donate what you can and if you are in need, we are here to help.
- The Fire Department has completed a four-month process of re-validation of our Medicare Providers' License. Medicare requires providers to basically re-license every 5 years due to widespread Medicare fraud. This process includes a site visit, EMS license review and so much more.
- The Fire Department completed our Texas Department of State Health Services, Emergency Medical Services, licensure in March. This re-licensure include affidavits from the Mayor, Fire Chief, Insurance provider and many more. The Medical Director certifies new medical protocols and required equipment that must be carried at all times. All personnel certifications are reviewed, and the required continuing education is reviewed. We will still have a site visit to inspect all ambulances.
- The Fire Department completed the application for funding to the Texas ASSP. This program provides additional funding for unpaid EMS bills. This is a three-month process, and the application is now in the States hands for processing. If additional funding will be awarded, we will be informed in the next 4 months.
