**Projects**

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

**Public Works**

- The plans for the FY 25 Street Maintenance Project are ready and will be advertised for bids on Wednesday April 30th and May 7th. Bids are to be opened on May 15th. Once they have been checked for accuracy, the City Engineer will make a recommendation, and the item will be taken to City Council for approval. We expect the work to begin in early summer. This year we will tackle a portion of Wurzbach Road (Evers Rd. to Bandera Rd.).
- The City Engineer is working on plans for the replacement of water mains on Pickering, Rimkus, and Kinman.
- Staff is finishing up the easement agreements for the right of way along William Rancher and along Aids Drive.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road.

**Additional Public Works Activities**

- Constructing concrete pad for outbuildings at kennel site.
- Will be deconstructing the LV swimming pool facility. The water has been pumped out of the pool and all physical items removed.
- Replacing traffic signs throughout the city.
- Setting up for Senior Bingo.
- Mowing Mow Zone 1 (Huebner Road, parks, hike & bike trail).
- Continuing to remove all items from LV community pool.
- Cleaning all parks after Easter weekend festivities.
- Mowing well sites.
- Taking water samples.
- Flushing dead end mains.
- Installing water line to kennel.
- Performing inspections at Seneca Trails for water and sewer main installs.

- Performing preventative maintenance on backhoes.
- Placing new weed eaters and blowers into service.
- Repairing lawnmowers
- Demolishing the LV swimming pool facility. The water has been pumped out of the pool, all physical items have been removed, and the baby pool has been demolished. Waiting on CPS to cut the energy to the facility prior to demolishing the large pool.
- Mowing Mow Zone 2 (Poss, Evers, Huebner, Pocket Parks).
- Setting up the Forest Oaks pool.
- Pulling pump room at LV Community pool.
- Performing disconnects/reconnects.
- Installing new pump at Grass Hill wellsite.
- Locating sewer lateral on Althea.
- Repairing water main leak on Pickering.
- Performing inspections at Seneca Trails for water and sewer main installs.
- Rebuilding sidewalk along Forest Pine.
- Checking drainage culverts for debris prior to expected rainfall events.
- Replacing sand at softball field, replacing soccer nets, cleaning up volley ball pits.
- Replacing Fire Dept. cabinets from vent hood installation.

#### **PW GRANTS**

- The engineer continues designing the El Verde Water Main Replacement Project. This project is being funded with a \$1,300,000 Bexar County ARPA grant. The project will be advertised for bids in April.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- The CDBG East of Wurzbach Sewer Main Replacement Project, awarded to Texas Utilities, has now been completed.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We have submitted 60% plans for review. Letting the project for bids is expected in October of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary for about three years. The Forester would be used to monitor Oak wilt disease, review tree removal requests, assure tree permits are being inspected, determine the condition of city trees in various parks, and make recommendations for removal or replacement of trees.
- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff applied for a grant from Bexar County CDBG to install a new sewer main along Locker Lane.

- Please remember that the LVFD is always willing to help change smoke detector batteries for residents who need assistance, please contact us and we will schedule an appointment.
- The Fire Department needs non-perishable food, dry goods, diapers and baby formulas to replenish our Community Care Box. Please donate what you can and if you are in need, we are here to help.
- In the last 60-day period, we collected 548 pounds of food. This food was distributed between two local food pantries that serve our community.

- The Fire Department attended the Leon Valley Elementary School’s Fiesta Parade. Our fire and EMS crews stayed after the parade and enjoyed some great food and treats. Students and parents were able to tour and climb on our fire trucks and honk the horn. A great time was had by all.
