SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- The FY 25 Street Maintenance Project contract has been awarded, and we are meeting with the contractor on Thursday of this week to determine their schedule. This year we will tackle a portion of Wurzbach Road (Evers Rd. to Bandera Rd.).
- The City Engineer is working on plans for the replacement of water mains on Pickering, Rimkus, and Kinman.
- The City Engineer is working on plans for replacing sewer mains on Forest Brook, Forest Ridge, Forest Mill, and Forest Knoll (2,700 +/- linear feet).
- Staff is finishing up the easement agreements for the right of way along William Rancher and along Aids Drive.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road.
- Sprinkler systems are being installed at the Ridge at Leon Valley Park and at Silo Park. Old Mill Park will receive a solar panel to provide power to that irrigation system.

Additional Public Works Activities

- Resuming work on the demolition of the LV swimming pool facility.
- Patching asphalt on Althea from sewer tie in.
- Repairing speed humps on Timberhill.
- Cleaning up flood debris.
- Mowing Mow Zone 3 (Grissom, Timberhill, Huebner).
- Replacing fire hydrant on Poss Road.
- Setting meter for carwash on Grissom.
- Reading meters.
- Repairing leaks in sprinkler system at library grounds.
- Completed mowing Bandera Road, and Huebner Creek along the LC-17. Mowing the Hike and Bike Trail and El Verde Rd. this week.

- Replacing Fire Dept. cabinets from vent hood installation.
- Replacing dead meters.
- Issuing hang tags for customers.
- Flushing dead end mains.
- Repaired a water main break on Peachtree.
- Performing a water tap on 7408 Linkwood.
- Performing inspections at Seneca Trails for water and sewer main installs.
- Performing preventative maintenance on backhoes and loader.
- Providing repairs for zero turn mowers.

PW GRANTS

- The engineer continues designing the El Verde Water Main Replacement Project. This project is being funded with a \$1,300,000 Bexar County ARPA grant. The project will be advertised for bids in April.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We will be submitting 100% plans for review in the next few weeks. Letting the project for bids is expected in October of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary for about three years. The Forester would be used to monitor Oak wilt disease, review tree removal requests, assure tree permits are being inspected, determine the condition of city trees in various parks, and make recommendations for removal or replacement of trees.
- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The application was accepted, and we will now be moved to Step 2 in the process. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff applied for a grant from Bexar County CDBG to install a new sewer main along Locker Lane.
