SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- The bids for the FY 25 Street Maintenance Project were opened on May 15th. The item will be taken to City Council for approval on June 3rd. We expect the work to begin in early summer. This year we will tackle a portion of Wurzbach Road (Evers Rd. to Bandera Rd.).
- The City Engineer is working on plans for the replacement of water mains on Pickering, Rimkus, and Kinman.
- Staff is finishing up the easement agreements for the right of way along William Rancher and along Aids Drive.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road.
- Sprinkler systems are being installed at the Ridge at Leon Valley Park and at Silo Park. Old Mill Park will receive a solar panel to provide power to that irrigation system. Staff is getting quotes for the Hike & Bike Trail irrigation system.

Additional Public Works Activities

- Resuming work on the demolition of the LV swimming pool facility.
- Cleaning out storm drains from the recent rains.
- Cleaning City Hall, Library, and parks.
- Mowing In Mow Zone 1 (Evers, Huebner).
- Changing out a/c filters in city buildings.
- Replacing fire hydrant on Poss Road.
- Repairing curb stop on Wurzbach.
- Mowing well sites.
- Performing inspections at Seneca Trails for water and sewer main installs. Performing preventative maintenance on loader.
- Taking inventory.

• Repairing water truck and air compressor.

PW GRANTS

- The engineer continues designing the El Verde Water Main Replacement Project. This project is being funded with a \$1,300,000 Bexar County ARPA grant. The project will be advertised for bids in April.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We will be submitting 100% plans for review in the next few weeks. Letting the project for bids is expected in October of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary for about three years. The Forester would be used to monitor Oak wilt disease, review tree removal requests, ensure tree permits are being inspected, determine the condition of city trees in various parks, and make recommendations for the removal or replacement of trees.
- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The application was accepted, and we will now be moved to Step 2 in the process. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff applied for a grant from Bexar County CDBG to install a new sewer main along Locker Lane.

The officers were patrolling the building as I was packing my belongings to move. I called them over to inspect my bathroom which smelled of cigarette smoke. I am not a smoker. On that day, I was not staying at my (paid) room due to a faulty boiler in addition to residents violating the no-smoking and no drug hotel rules. Officer Breton confirmed that he smelled some cigarette smoke in my bathroom, and they were patrolling the building due to marijuana odors. I expressed concern that maintenance personnel entered my room without my knowledge and smoking or smoking in the maintenance closet adjacent to my room. I have seen hotel residents smoke in their doorway or come out of their room smoking. See photos as an example. The hotel is a non-smoking hotel. The following is background information: On March 15, 2025, I called InTown Suites Reservation line to book a stay at InTown Suites on 6923 San Pedro Ave., San Antonio TX 78216. My reservation number was 3J4AT7RH9 (See attached document). When I arrived at that InTown Suites on March 15, 2025, the manager, LaTonya informed me that the manager at the InTown Suites on Bandera Road-Leon Valley, John Mentor, emailed all managers of InTown Suites in San Antonio, instructing them not to rent to me. I was currently a paid "resident" by Texas law through March 20, 2025 at the InTown Suites at Leon Valley South. However, I could no longer stay in my assigned Hotel room due to a faulty broiler room affecting my health. I chose to move to the InTown Suites on San Pedro because their Broiler Room/chimneys were designed so that no rooms would be affected by vent fumes.
