SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- Clark Construction of Texas has completed the mill and overlay of Wurzbach Road, from Bandera to Evers roads. The concrete sections will be completed in the next week and roadway striping will take place in about 14 days, which allows time for the asphalt to completely cure.
- The City Engineer is preparing plans for the replacement of water mains on Pickering, Rimkus, and Kinman.
- The City Engineer is preparing plans for replacing sewer mains on Forest Brook, Forest Ridge, Forest Mill, and Forest Knoll (2,700 +/- linear feet).
- Staff is finishing up the easement agreements for the right of way along William Rancher and along Aids Drive.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road.
- Sprinkler systems are being installed at the Ridge at Leon Valley Park and at Silo Park. Old Mill Park will receive a solar panel to provide power to that irrigation system.
- Staff is working on estimates for a possible new community garden.

Additional Public Works Activities

- Resuming work on the demolition of the LV swimming pool facility.
- Repairing speed humps on Timberhill.
- Cleaning up flood debris.
- Preparing Raymond Rimkus Park grounds for 4th of July.
- Mowing Mow Zone 2 (Bandera Road and pocket parks).
- Replacing fire hydrant on Poss Road.
- Setting water meter for carwash on Grissom and in Linkwood for new home.
- Taking water samples.
- Flushing dead end mains.
- Repairing leaks on Cherryleaf, behind Peter Piper, and at the library grounds.

- Repairing leaks identified by leak detection service.
- Repairing vibrator plate.
- Performing preventative maintenance on Police Department ATV's.
- Repairing mosquito trailer.
- Repairing equipment trailer.
- Constructing berm in Old Mill Park to prevent excess stormwater runoff to Gristmill residents.
- Mowing Mow Zone 1 (Evers Rd and Public Works).
- Cleaning up remaining items in park from 4th of July celebration.
- Clearing out drainage easement at Althea.
- Setting water meter for carwash on Grissom and in Linkwood for new home.
- Ordered new meter for Edwards Aquifer metering existing one was hit by lightning.
- Repairing lawnmower.
- Repairing vacuum trailer
- Repairing power washer.
- Replacing cylinder on backhoe.
- Re-installing sign on Althea
- Repairing asphalt around sewer main on Evers at Forest Way.
- Installing privacy strips on restroom stalls at library.
- Installing replacement see-saw at Raymond Rimkus Park.
- Repairing all benches in all parks.
- Performing re-reads and changing out dead meters.
- Setting water meter for carwash on Grissom
- Mowing Mow Zone 3 (Grissom, Timberhill, Huebner).

PW GRANTS

- The engineer has almost completed the design of the El Verde Water Main Replacement Project. This project is being funded with a \$1,300,000 Bexar County ARPA grant. Bids will be advertised at the end of July.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We will be submitting 100% plans for review in the next few weeks. Letting the project for bids is expected in October of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary for about three years. The Forester would be used to monitor Oak wilt disease, review tree removal requests, assure tree permits are being inspected, determine the condition of city trees in various parks, and make recommendations for removal or replacement of trees.
- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.

- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff applied for a grant from Bexar County CDBG to install a new sewer main along Locker Lane.

FIRE DEPARTMENT

- The Fire Department has started their annual School Supply Drive. This drive aims to provide necessary school supplies to students in Leon Valley that may not have the means to purchase them. The Fire Department will have yellow collection barrels at the fire department, city hall and the library. We will be collecting through September 1st. please stop by and donate, every single item helps a child.
- The Fire Department currently has two firefighters working in Kerrville, supporting the • recovery efforts. Both firefighters are former Kerrville firefighters and have strong ties to that community.
- The Fire Department hosted its quarterly Blood Drive on July 3rd. This was the day it really rained hard, and all the flooding occurred. While only 8 units of blood were donated, that's still pretty good considering the rain and flooding.
- Please remember that the LVFD is always willing to help change smoke detector batteries for residents who need assistance, please contact us and we will schedule an appointment.
- The fire department received a request from Kendall County OEM. This request was for 3 • firefighters and an engine to back fill one of the Kendall County fire stations while crews were deployed. This request stems from the flooding incident in Kerr County on July 3rd. Both Kendall and Comal Counties were affected and have major rescue and recovery efforts ongoing.
- The Fire Department needs non-perishable food, dry goods, diapers and baby formulas to replenish our Community Care Box. Please donate what you can and if you are in need, we are here to help. The Fire Department distributed 246 pounds of non-perishable foods between residents in need and local food banks. Donated diapers and baby formula were donated to the Texas Diaper Bank. Our department encounters residents in need of assistance when responding to calls on a regular basis. Our crews often return to the scene with food, toys, blankets, and other items that are available.
