SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- The City Engineer has completed plans for the replacement of water mains on Pickering, Rimkus, and Kinman. This project is being advertised for bids.
- The City Engineer has completed plans for replacing sewer mains on Forest Brook, Forest Ridge, Forest Mill, and Forest Knoll (2,700 +/- linear feet). This project will be bid in August.
- Staff has finished acquiring an easement for 10' of right of way along William Rancher. Closing will take place this week.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road and along Aids Drive.
- Sprinkler systems have been installed at the Ridge at Leon Valley Park and at Silo Park. Staff will be hiring an outside contractor to extend the water main on Huebner to Silo Park to connect the sprinkler system.
- We will be installing a traffic warning sign on Evers at Adair.

Additional Public Works Activities

- Finishing up the demolition of the LV swimming pool facility. City Crews will now demolish the structures.
- Repairing speed humps on Timberhill.
- Mowing creek beds and drainageways.
- Repairing boards on benches at all city parks
- Setting water meter for carwash on Grissom and in Linkwood for new home.
- Ordered new meter for Edwards Aquifer metering existing one was hit by lightning.
- Repairing water main break on Yellow Rose.
- Repairing lawnmower.
- Repairing power washer.
- Replacing cylinder on backhoe
- Replacing 5 fire hydrants

- Repairing roadway on Stebbins.
- Repairing manhole on Forest Ridge at Forest Brook.
- Performing a mill & overlay on 184' of trail at Raymond Rimkus Park
- Mowing pocket parks and Aquarium detention pond.
- Installing park signage at Raymond Rimkus Park.
- Cleaning up Public Works yard.
- Repairing vacuum trailer.
- Preparing for auction

PW GRANTS

- The El Verde Water Main Replacement Project is being funded with a \$1,300,000 Bexar County ARPA grant. Bids are being advertised and will be taken to City Council for approval once tabulated.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being advertised for bids.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We will be submitting 100% plans for review in the next few weeks. Letting the project for bids is expected in October of 2025.
- Staff applied for a grant to acquire the services of a Forester. The grant will pay a salary
 for about three years. The Forester would be used to monitor Oak wilt disease, review
 tree removal requests, assure tree permits are being inspected, determine the condition
 of city trees in various parks, and make recommendations for removal or replacement
 of trees.
- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. This grant will pay \$100,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff applied for a grant from Bexar County CDBG to install a new sewer main along Locker Lane.
