SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

PUBLIC WORKS

- The City Engineer has completed plans for replacing sewer mains on Forest Brook, Forest Ridge, Forest Mill, and Forest Knoll (2,700 +/- linear feet). This item will go to City Council for award to R.L. Jones, LP on November 18th.
- Staff will be meeting with the contractor for the FY 25 Water Main Replacement project to give a Notice to Proceed.
- Staff is working on the condemnation process to gain ownership of the portion of Zarzamora Creek in front of 5601 Bandera Road and along Aids Drive.
- We will be installing a traffic warning sign on Evers at Adair.
- Staff is investigating costs to construct a trail from the new Seneca Trails subdivision to the City of San Antonio's trail system in Huebner Creek.
- Staff will be reviewing the city's ADA Manual and making some renovations per the direction of the manual.

Additional Public Works Activities

- Lifting asphalt on Caraway Bend at manholes.
- Cleaning out and repairing scour and erosion in the creek off of Canterfield.
- Building a concrete pad at the Animal impound lot.
- Continuing with holiday decorating.
- Finishing installation of new flood gates.
- Rehabbing volleyball pits at Raymond Rimlkus Park.
- Repairing the washout at the small pavilion driveway.
- Spreading wildflower mix along Hike & Bike Trail and at Community Garden wildflower areas.
- Reading meters.
- Replacing 10 dead/malfunctioning meters.
- Repairing a small water main leak on Trotter.
- Repairing PW truck.

- Replacing sewer jet tires.
- Licensing a new wood chipper.
- Assisting Police with auction vehicles.
- Submitting quotes for new equipment in the next fiscal year
- Repairing sidewalk at 7208 Linkcrest.
- Installing parking signage at City Hall.
- Repairing the street on Caraway Bend near the manhole.
- Planting left over Arbor Day trees along Hike & Bike Trail.
- Changing out four fire hydrants in back of Bandera Heights Shopping Center.
- Reconfiguring utility billing software for new tiers and rates.

PW Grants

- The El Verde Water Main Replacement Project is being funded with a \$1,300,000 Bexar County ARPA grant. The contract was awarded to D&D Construction, and staff will be meeting with them to give them the Notice to Proceed.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded on January 7th. The bid was awarded at the October 21st City Council meeting to Sovrex LLC. Staff will be meeting with them to give them the Notice to Proceed.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II. We have submitted 100% plans for review. Letting the project for bids is expected in January of 2026.
- Staff applied for a grant for a Hike & Bike Trails Master Plan from the AAMPO. We were awarded this grant in the amount of \$230,000 for a planning document for the city's trail and shared path system. The city does not have a matching funds requirement, so if granted, the work would be performed at no charge to the city.
- Staff applied for a grant from the AAMPO for the Hike & Bike Trail Segment 3. The trail will connect at Evers Road and align with Huebner Creek up to Balky at the northern city limits line and connect to the City of San Antonio's trail system, which is already in engineering and design.
- Staff was awarded a grant in the amount of \$590,423 from Bexar County CDBG to install a new sewer main along Locker Lane. Plans are being developed for the project.
- Staff applied for a 50/50 matching grant to rehabilitate the Forest Oaks Community Pool. Grant awards are not expected until January 2026.
