ORDINANCE No. 2022-21

AN ORDINANCE OF THE CITY OF LEON VALLEY, TEXAS CITY COUNCIL AWARDING A BID TO R.L. JONES, LP IN THE AMOUNT OF \$504,449.00 WITH \$75,667 (15%) FOR CONTINGENCY, AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH R.L. JONES, LP FOR THE BLACKSMITH LANE WATER AND SEWER MAIN REPLACEMENT PROJECT AND AUTHORIZING A FY 2021-2022 ENTERPRISE FUND BUDGET ADJUSTMENT IN THE AMOUNT OF \$621,716.00; PROVIDING SEVERABILITY; REPEAL; AND AN EFFECTIVE DATE.

WHEREAS, it is the overall goal of the City of Leon Valley to continue work on Capital and Planning Projects; and

WHEREAS, in order to further these goals, the City of Leon Valley applied for a Community Development Block Grant with Bexar County to fund a portion of the Blacksmith Lane Water and Sewer Main Replacement Project; and

WHEREAS, the City of Leon Valley was recently notified of award of the Community Development Block Grant Program in the amount of \$143,639 to cover a portion of water and sewer main replacement expenses; and

WHEREAS, Texas Local Government Code Section 102.010 provides that a municipality is not prohibited from making changes to a budget for municipal purposes; and

WHEREAS, it is necessary to adjust the Enterprise Fund Budget in the amount of \$621,716 in order to construct the Settlers Ridge Water and Sewer Main project and receive a reimbursement by the County of Bexar; and

WHEREAS, the Leon Valley City Council desires to authorize the acceptance of the lowest responsive bid from R.L. Jones, LP in the amount of \$504,449 with \$75,667 (15%) for contingency to construct the Blacksmith Lane Water and Sewer Replacement Project, and authorize a FY 2021-2022 Enterprise Fund Budget adjustment in the amount of \$621,716.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS:

SECTION 1. The lowest responsive bid of \$504,449.00 from R.L. Jones, LP for the Blacksmith Lane Water and Sewer Replacement Project is hereby accepted. All other bids will be considered rejected upon the execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever occurs first.

SECTION 2. The City Manager is hereby authorized to enter into a contract with R.L. Jones, LP for performance of the work as specified in the Blacksmith Lane Water and Sewer Main Replacement Project.

SECTION 3. The Enterprise Fund budget for FY 2021-22 is hereby adjusted in the amount of \$621,716 for the construction of the Blacksmith Lane Water and Sewer Main Replacement Project.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable, and if any phrase, clause, sentence, or section of this Ordinance shall be declared unconstitutional or invalid by any court or competent jurisdiction, such unconstitutionality or invalidity shall not affect any other remaining phrase, clause, sentence, paragraph, or section of this Ordinance.

SECTION 6. The repeal of any Ordinance or part of Ordinances effectuated by the enactment of this Ordinance shall not be construed as abandoning any action now pending under or by virtue of such Ordinance or as discontinuing, abating, modifying, or altering any penalty accruing or to accrue, or as affecting any rights of the municipality under any section or provisions at the time of passage of this Ordinance.

SECTION 7. This Ordinance shall become effective immediately upon its passage and publication as required by law.
