

ORDINANCE No. 2022-22

AN ORDINANCE OF THE CITY OF LEON VALLEY, TX, CITY COUNCIL AMENDING THE STORMWATER FUND BUDGET OF THE CITY OF LEON VALLEY, TEXAS MUNICIPAL BUDGET IN THE AMOUNT OF \$42,115 FOR FISCAL YEAR 2021-2022 TO PROVIDE FUNDING FOR FLOOD MONITORING SOFTWARE UPGRADES; PROVIDING FOR REPEALER, SEVERABILITY AND SAVING CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Leon Valley passed the FY 2021-2022 Budget on August 17, 2021; and

WHEREAS, City Council approved the budget for the Stormwater Fund for FY 2021-2022; and

WHEREAS, staff has determined that funding should be added to the FY 2021-2022 Stormwater Fund Budget to provide upgrades to the flood monitoring system; and

WHEREAS, in order to fund these upgrades, it is necessary to adjust the Stormwater Fund Budget by \$42,115; and

WHEREAS, Texas Local Government Code Section 102-0120 provides that a municipality is not prohibited from making changes to a budget for municipal purposes; and

WHEREAS, the Leon Valley City Council now desires to amend the Stormwater Fund Budget for FY 2021-2022 in the amount of \$42,115 for Flood Monitoring Software upgrades.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS, THAT:

SECTION 1. The FY 2021-2022 Stormwater Fund Budget of the City of Leon Valley is hereby amended to increase the budget in the amount of \$42,115 to provide funding for the flood monitoring system.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Finance Director. The Finance Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations as necessary to carry out the purpose of this Ordinance.

SECTION 3. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable, and if any phrase, clause, sentence, or section of this Ordinance shall be declared unconstitutional or invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any other remaining phrase, clause, sentence, paragraph, or

section of this Ordinance.

SECTION 4. The repeal of any Ordinance or part of Ordinances effectuated by the enactment of this Ordinance shall not be construed as abandoning any action now pending under or by virtue of such Ordinance or as discontinuing, abating, modifying, or altering any penalty accruing or to accrue, or as affecting any rights of the municipality under any section or provisions at the time of passage of this Ordinance.


SECTION 5. This Ordinance shall become effective immediately upon its passage and publication as required by law.


