AMERICAN RESCUE PLAN (ARP)

The City of Leon Valley received the first of two payments of approximately \$1.5 million dollars each from the Biden Administration under the American Rescue Plan in August, 2021 and we are expected to receive the second installment in September, 2022. In the first installment of dollars received, there were four main categories of eligible uses. These categories have been removed and the City can spend the second installment for its greatest needs. We will definitely get your input on how to spend these tax dollars wisely. The total allocation must be spent by the end of 2024.

THOUGHT YOU'D LIKE TO KNOW

• The Bandera Road Corridor Study Group will hold a public meeting in mid to late October, 2022 to present the recommended concept which TXDOT and its consultant, Halff & Associates, The City of San Antonio, and Leon Valley have developed after 4 years of planning, with extensive citizen input. The preferred alternative is the At-Grade Parkway concept (adding an additional lane in each direction) with reductions of available left turns to reduce congestion. Additionally, 10 foot protected bicycle and pedestrian lanes on both sides of Bandera Road from 410 to 1604 will be added for safety and connectivity to the neighborhoods and businesses. Currently there is no funding identified for the project, but State Representative Ray Lopez is working at the State Legislature for a possible appointment to the Transportation Committee, to help secure much needed dollars.

Notification of the meeting will be sent to anyone who has participated in one of these planning meetings, as well as through social media, newspaper and electronic signs. This public meeting will be both virtual and in-person. Hope to see you there. Check the city's website for the date and time in October. The meeting will be held at City Church on Bandera Road.

- The City of Leon Valley is currently in litigation with the owners of Vista del Rey Apartments for health and safety code violations. The estimated cost of Leon Valley's attorney fees will be \$100,000. There is a remedy in the lawsuit filed where for every code violation not corrected (after notice of the code violation), penalty of up to \$1,000 per day per violation can be assessed by the Judge against the apartment owners. The Judge has given the apartment until mid-September to correct the health/safety issues and six months (Feb. 2023) to correct the remaining issues.

With a robust search interface, thumbnail images hit highlighting, easy-to-use tools, and convenient in-library or remote access through the library portal, it's easy to see why HeritageQuest continues to be one of the most recommended resources by family history publications and genealogists.

Udemy

Udemy is an online learning platform that provides instructions for adults who want to gain new skills for a new job, advance in their current profession, or deepen a personal interest. It contains more than 15,000 video-based courses in business, technology, software, and personal development.

DID YOU KNOW.....?

On July 19, 2022, the City of Leon Valley City Council adopted Ordinance No. 2022-34 amending the City's Code of Ordinances, Chapter 1, Article 1.04 City Council, Section 1.04.001 Rules of Decorum.

The following amendments were made:

- <u>Sec. 1.04.001, (b) Meeting Times</u>. A Regular City Council Meeting shall be held on both the first and third Tuesdays of each month **beginning at 6:30 PM**. In the event that the meeting date falls on a holiday, the meeting will be rescheduled. Regular City Council Meetings may be cancelled or rescheduled, and the meeting time adjusted upon a majority vote by City Council. Special meetings may be called as provided by law.
- <u>Sec. 1.04.001, (d) Conducting Meetings, (2) Appearance</u>. Citizens may appear in person.

Citizens may appear by written appearance for items on the agenda.

The deadline to register is Tuesday, October 11, 2022

Why Leon Valley Utilizes Bexar County Communications for Dispatch Services

Prior to moving dispatch services to Helotes, Leon Valley housed its own dispatch services. Due to manpower issues and aging equipment, the decision was made to move services to Helotes. In January 2017, Leon Valley utilized the Helotes **Communications Center to** house personnel to dispatch first responders (Fire, EMS and Police) for Leon Valley residents. At the time, the Helotes Communications Center dispatched for the cities of Helotes, Leon Valley, Shavano Park and Grey Forest. The services were provided at a cost to the city of Leon Valley. In late 2017, the City of Leon Valley requested and eventually received dispatch services from Bexar County in 2018. Multiple factors prompted the request; however, the primary considerations were budgetary concerns. Bexar County had recently opened and was operating their new Bexar Metro 911 Emergency Center. This new center is a state-of-the-art facility with dedicated call takers

and dispatchers. The personnel and equipment at this facility are supported by multiple levels of redundancy to ensure undisrupted service delivery during normal and catastrophic conditions. Currently, we continue to utilize Bexar County Communications for Leon Valley dispatch services.

After the change in service provider, there have been several calls from Leon Valley residents over the last few years to return to the "old days" when Leon Valley operated its own communications center. Since the "old days", there have been many changes in minimum requirements for running an emergency communications center. The first to address is the type of equipment required to operate a center. This comes at a very high cost. The second is the required personnel to staff and operate this center twentyfour-hour a day, seven day a week, 365 days a year. The third is the required office space and security for the center to ensure operability under normal and

catastrophic conditions. These initial and continuing costs would be overwhelming and harmful to the city's financial well-being.

Although Helotes started operating its communications center in 2010 and anticipated its continued delivery of services to other cities, they have encountered their own difficulties in continuous operation. Although their center was operated by Helotes, it was funded by Helotes, Leon Valley, Shavano Park and Grey Forest. In 2021-2022 due to funding shortfalls, they have requested services or financial assistance from Bexar County. Several articles on this topic are archived and can be found on the internet.

Currently, the level and reliability of services provided by the Bexar Metro 911 Emergency Center cannot be duplicated by the City of Leon Valley within acceptable budgetary limitations.


Receiving communication services from Bexar County has brought numerous benefits for the city and its first responders. One of the most important benefits for the city's first responders is the ability to communicate with first responders from other agencies. The most important benefits for residents are continuity and reliability.

There have been problems since the change in service provider but there will always be problems to resolve with any provider of services when dealing with human interactions and technology. This isn't new as we addressed problems when we utilized Helotes for dispatch services also.

Things you should know:

If you have an emergency, dial 911. Your call will be answered by a dedicated operator. If your emergency does not rise to the level of other calls being received at the same time, you may be put on hold. Several operators are on duty at the same time and are taking calls as they are received. The level of emergencies will be prioritized.

If you require non-emergency services, please call 210-684-8897 or 210-335-6000. Once again, there are multiple call takers receiving calls at the same time. Calls for service will be prioritized.


WHY IS RECYCLING IMPORTANT?

Saving Lives with Whole Blood: Cutting Edge EMS Treatment now available at the Leon Valley Fire Department

This life saving initiative which launches this September will allow Leon Valley EMS to provide whole blood transfusions inside ambulances to people who have suffered major blood loss. The process starts with the South Texas Blood and Tissue Center which provides Type O whole blood, which is blood that anyone can receive, to Leon Valley EMS, which keeps it in storage coolers in our ambulances. The blood is heated by a portable fluid and blood warming device before being administered as first responders transport patients. "Giving the patient what they need when and where they need it will save lives at a much higher rate," states Fire Chief Michael Naughton, "And it is important to me that Leon Valley continue to stay up to date with new medical advances and today we are proud to say we on the cutting edge with Whole Blood".







Free Trees! 2022 Leon Valley Tree Adoption Event
