REQUIREMENTS

Be a Bexar County resident

What do I need to apply?

Provide the following for all household members:

- Proof of U.S. Citizenship - U.S. Passport, or Birth Certificate, Permanent Resident Card, Certificate of Naturalization
- Proof of Identification - Current Drivers License or ID (cannot be more than 2 yrs expired)
- Social Security Card(s)
- Proof of income received in the last 60 days - Check stubs, Social Security award letters, Unemployment, Child Support, SNAP, TANF, HAP, etc
- Utility Bill
