MEET YOUR LEON VALLEY CITY COUNCIL **MEMBERS**

On May 3rd , Leon Valley election for at-large Places 1, 3 and 5 resulted in two changes on city council. In Place 1, Danielle Bolton was elected with 374 votes (62.2%) to Councilor Benny Martinez' 227 votes (37.8%). In Place 3, incumbent Councilor Philip Campos was re-elected without opposition. In Place 5, Councilor Will Bradshaw chose not to run for a fourth term and newcomer Beth Mursch was elected without opposition. Returning to council to complete the second year of his third two-year term is Councilor Rey Orozco. Councilor Betty Heyl is completing her second year of her first term and I am completing my 11th term as Mayor. 671 citizens cast a vote in our municipal election out of 7,536 eligible registered voters for an 8.9% turnout.

New Councilor Danielle Bolton has lived in Leon Valley since 1976 and graduated from John Marshall High School. She has been married for 29 years and has two children. She earned a BS and MA from

UTSA and has been an assistant principal since 2015. Danielle has served on the Park Commission, the Board of Adjustment and the Economic/Community Development committee. She also serves on the Board of Directors of the Leon Valley Historical Society and is a committee member of the San Antonio Stockshow Horse Committee for the last 20 years.

Councilor Philip Campos is a native San Antonian, graduating from Thomas Jefferson High School where he met his wife Anna. Interestingly, they have lived in three different homes in Leon Valley over their married life, and they have lived in Leon Valley for 46 years! They have 3 children and 9 grandchildren. He graduated from Texas A&M University and is a certified public accountant. After owning his own CPA firm for many years, Philip transitioned to working for the City of San Antonio for 4 years and then the San Antonio Water System for 16 years. He served as Senior Contracting Director at SAWS, managing over \$500 million in contracts, and retired at the end of 2024. He continues to work as a CPA.



New Councilor Beth Mursch has lived in Leon Valley since 1985, raising three children. If you knew Mursch Sporting Goods Store on Bandera Road, that was her husband's family business. Beth graduated with a BS in biology from St. Mary's University and an MBA in Healthcare Management from Our Lady of the Lake University. She worked as a Laboratory Manager and Director for 36 years, first at CHRISTUS Santa Rosa, then as a traveling Interim Laboratory Directory in hospitals/ healthcare organizations outside of San Antonio. Councilor Mursch has been a member of the Earthwise Living Committee since 2023, and was elected Chair in 2024. She has served as an Alternate of the Planning & Zoning Commission since 2024. She enjoys spending time with her nine grandchildren and walking/gardening.

The Council decided to forego the annual parade due to the heat and dwindling parade participation, and to concentrate only on the July 4th celebration in the park. Food trucks and the small business-sponsored Fun Zone for kids will be held from 6 pm – 9 pm. Director Miranda is working on securing a jazz band who would open the festivities. Our cover band, Finding Friday, will perform from 7:30 - 10 pm with the fireworks display beginning at 9:30 pm. Finding Friday will continue to play after the fireworks until 10 pm. This is a free event and participants may bring in coolers, chairs and blankets to enjoy the music and festivities.

WATER & SEWER RATES INCREASED

Since February 2024 City Council has been discussing the need to increase water and sewer rates, initially to cover the cost of repairing 6 water mains in Seneca West subdivision and the sewer mains in Forest Oaks. Councilors were shown photos of severe leakage in 50 year old pipes. Clean water is a health, safety and welfare issue which we as a city council must provide to protect our citizens.

At the Town Hall meeting the citizens supported a 2% increase in rates and council directed staff to apply the calculations. Unfortunately, the numbers did not generate enough money.

At the May 6th meeting, I as mayor broke a 2-2 tie to vote for the first year's increase for water and sewer rates of 4%, or \$3.24 more per month for 5,000 gallons per month usage, with an additional 5% in year two (a total of \$3.76 per month over current rates). The Council will reassess rates in two years, after reviewing revenue changes resulting from new homes slated to be built in Seneca West, Trilogy Grove and Senna I and II in Leon Valley. The Council's goal is to charge equivalent rates to those paid by SAWS customers (about 1/3 of Leon Valley residents are on SAWS water, and Leon Valley sewer. They will pay the sewer fee increase).

DID YOU KNOW?

• City Council Summer Meeting Schedule – June 3rd was the last meeting held in June with both the June 17th and July 1st council meetings cancelled for a summer break. Council meetings will resume the 1st and 3rd of each month beginning July 15th . The quarterly Coffee with the Mayor and Council is set for Saturday, July 26th from 9 – 11 am at the Leon Valley Conference Center.

 The Importance of Nature – Time in nature improves mental health, enhances focus, lowers stress hormones, and makes you feel good. On May 10th we took our granddaughter Betty to the Natural Area Park. It is a .8 mile hike in a dense forest. She counted 15 deer sightings and we recorded 10 bird sounds on our free Merlin bird app. She thought the Joseph Huebner gravesite, made from limestone, was really cool, especially with the obelisk. By the way, it is always at least 5-10 degrees cooler in the Natural Area. The entry is around from the Community Garden in Rimkus Park, next to the entrance on Forest Meadow.

• The Forest Oaks Community Pool located at 6620 Evers is open from Memorial Day weekend May 24-September 1st and weekends only September 6-28th. Hours are 10 am – 8 pm, Sunday – Saturday, CLOSED on Wednesdays. Season passes are available online. Daily gate fee is \$5. Party rentals are available. Unfortunately, there will not be a swim team this year (no coach).

5 Steps to Safe Digging



Texas law requires you to contact 811 at least two business days before every dig. No matter how big or small. **811 is a free service.**

CONTACT 811

Always contact 811 at least 48 hours before you dig. Digging is defined as the movement of earth by any means.

WAIT 48 HOURS

Always wait at least 48 hours before starting your digging project.

CONFIRM THE MARKS

Confirm that all utilities have been marked prior to starting your digging project.

RESPECT THE MARKS

The paint or flags are the guide for your digging project. It may be necessary for a remark if the flags are removed or the paint fades.

DIG CAREFULLY

Be mindful of tolerance zones and dig with caution around the utility markers.



The Leon Valley City Council recently adopted the following ordinances:

Ordinance No. 2025-7 - An ordinance of the City of Leon Valley, TX., City Council authorizing a budget adjustment to the FY 2024-2025 General Fund Budget in the amount of \$35,000 for the purpose of increasing the Public Works Department to provide funding for the demolition of the Leon Valley Community Swimming Pool. – Adopted 04-01-2025

Ordinance No. 2025-8 - An ordinance of the City of Leon Valley, TX., City Council granting a zone change on an approximately 6.8 acre tract of land from R-1 Single-Family Dwelling District to Planned Development District (PDD), with R-3 Multiple-Family Dwelling Base Zoning District being the Northwest 330' of Lots 10, 11, 12, 13, and the Northeast 20' triangle of Lot 10, and the Southwest 400' of Lot 3, CB 5874, Leon Valley, Texas. - Adopted 04-15-2025

Ordinance No. 2025-9 - An ordinance of the City of Leon Valley, TX., City Council amending Ordinance 2021-54 to change the zoning from PD Planned Development District, with B-3 Commercial District and no SO, Sustainability Zoning to PD Planned Development District with R-3 Multiple-Family Dwelling Base Zoning District on approximately 2.85 acres at 6758 Poss Road; and more specifically described as CB 5784, Block 4, Lot 64, Quality Subdivision, Leon Valley, Texas. - Adopted 04-15-2025

Ordinance No. 2025-10 - An ordinance of the City of Leon Valley, TX., City Council amending the Leon Valley Code of Ordinances, Appendix A, Fee Schedule, Article A11.000 Water and Sewer Fees, Section A11.001 (a), (c), (g), and (q); providing an effective date of the first day of the Water Billing Cycle for October 2025, an effective date for the Sewer Billing Cycle for October 2025. - adopted 05-06-2025

Ordinance No. 2025-11- An ordinance of the City of Leon Valley, TX., City Council authorizing a budget adjustment to the FY 2024-2025 Police Forfeiture Fund in the amount of \$8,500.00 from the General Fund for the capital acquisitions of a vehicle. - adopted 05-06-2025

Protecting Leon Valley from White Collar Crime

At the recent Citizens Police Advisory Committee meeting, we explored how White-Collar crimes are impacting the Leon Valley community. These crimes—often non-violent—are committed for financial gain and can affect anyone. The topics discussed included credit and debit card fraud, identity theft, financial abuse of the elderly, and mail theft.

Credit & Debit Card Abuse

Definition: Unauthorized use of a credit or debit card to obtain money, services, or goods fraudulently.

Recent Trends:

- Skimming devices at ATMs and gas pumps
- Online fraud using stolen card data

Prevention Tips:

- Use chip or tap-to-pay cards rather than swiping
- Set up text or email transaction alerts
- Regularly review your bank statements for suspicious activity

Real-Life Story:

I use the Starbucks app and have my account set to reload automatically. While reviewing recent transactions, I noticed unauthorized purchases in Austin, despite never leaving Leon Valley. I contacted Starbucks immediately and was able to resolve the issue. No one is immune to these incidents.

Contactless Payments: A Safer Option

Contactless payments use Near Field Communication (NFC) technology to generate a one-time, unique code for each transaction. Your actual card number is never transmitted to the merchant.

Why It's Safe:

- Reduces risk of skimming or cloning
- No need to hand over your card
- Fast, secure, and convenient







Financial Abuse of the Elderly

Definition: Exploitation of an elderly person's finances through deception, coercion, or manipulation.

Recent Trends:

- Romance and impersonation scams
- Caregivers misusing financial access

Prevention Tips:

- Assign a trusted financial power of attorney
- Regularly review financial statements with loved ones
- Educate elderly family members on common scams

Real-Life Story:

A scammer called an elderly resident claiming a loved one has been detained at the border and needed to send money via Apple gift cards or wire transfer. The criminal was able to obtain a substantial amount of money from the resident. It was discovered this was a fraud tactic.

Fraudulent Use of Card Information

Definition: Using or possessing another person's card data without consent.

Recent Trends:

- Data breaches
- Card information sold on the dark web

Prevention Tips:

- Use strong, unique passwords on every website
- Avoid using personally identifiable info (birthdays, pet names, etc.) in passwords
- Never share sensitive information via email or unsolicited calls

Real Life Story:

A local resident used the same password across several online shopping sites. After a major breach, multiple fraudulent purchases occurred. Changing passwords often and using password managers can greatly reduce this risk.

Identity Theft & Synthetic Identity Fraud

Definition: Using real or fake personal information (e.g., Social Security numbers, driver's license numbers) to commit fraud.







Recent Trends:

- Creating fake identities by combining real SSNs with made-up names and birthdates (commonly using children's or elderly individuals' information)
- Phishing texts or emails posing as banks or government agencies

Prevention Tips:

- Shred all personal and financial documents before discarding
- Enable two-factor authentication on your accounts
- Monitor your credit using services like Credit Karma, Credit Sesame, or your bank's free tools

Mail Theft & Check Washing

Definition: Stealing physical mail to obtain personal or financial information, checks, or packages.

Recent Trends:

- "Washing" stolen checks to alter payees and amounts
- Package theft, often called "porch piracy"

Prevention Tips:

- Use locking or USPS-approved mailboxes
- Sign up for Informed Delivery from USPS to preview your incoming mail
- Pick up your mail and packages promptly
- Use Amazon locker pickup—there's one conveniently located in front of City Hall

Real Life Story:

An Amazon delivery vehicle was followed through neighborhoods and the package thieves retrieved delivered items after they were dropped off on front porches.

Summary: Protecting Our Community Together

White collar crimes can happen to anyone—young or old. While many of these offenses occur behind the scenes, the financial impact can be devastating. Education and prevention are key.

Leon Valley residents: stay alert, stay informed, and take steps to safeguard your personal information. If something seems suspicious, report it. Together, we can prevent crime and protect one another.
