ORDINANCE

Discussion and Action to Consider Approval of an Ordinance Amending the Leon Valley Code of Ordinance, Chapter 1 General Provisions, Article 1.06 Boards, Commission and Committees, to Establish a 2021 Capital Facilities Bond Oversight Committee, to Assure the Effective, Efficient, and Lawful Use of Bond Funds Procured for the Demolition, Construction, and Renovation of the Leon Valley Community Pool, the Forest Oaks Community Pool, the Library Annex, and the Leon Valley Public Works Facilities (1st Read was Held on 01-12-2021) (M&C # 2021-03-09-02 M. Moritz)

Melinda Moritz, Public Works Director presented the item saying that there were no changes but did make a suggestion to remove the word "bond" from the document and just leave it as the Facilities Oversight Committee.

Councilor Josh Stevens suggested amending the proposed ordinance to include an addition of two (2) alternate members to the committee.

A motion was made by Councilor Will Bradshaw to adopt the ordinance with the amendments that the word "Bond" be removed throughout the document; and that two (2) alternate members be added. The motion was seconded by Councilor Rey Orozco.

Presentation, Discussion and Possible Action on an Ordinance Adopting Texas Governor Abbott's Executive Order GA-34; and Bexar County Judge Wolff's Executive Order NW-19; and Amending the Emergency Disaster Ordinance Local Emergency Declaration 2021-002 (M&C # 2021-03-09-03 D. Gonzalez)

David Gonzalez, Police Chief presented the item beginning with the Governors order.

A motion was made by Councilor Jed Hefner to approve Ordinance No. 7.2 (Actually Agenda Item 7.2 which is Ordinance No. 2021-10), adopting Executive Order No. GA-34 with the following caveats: that we will require masks at all City functions, following the procedures to ask them to leave if they don't and even follow up to that if we need to; maintain the six-foot (6') distancing; require no gloves at the Library; open the senior citizens, again following these caveats that we've just set down; Municipal Court - limited to technology courts but it will be opened up according to the judge; Library - we will follow Phase IV as presented but with no gloves; pools will be opened as discussed; soccer fields, baseball fields and pavilion will be opened up as proposed. The motion was seconded by Councilor Will Bradshaw.

Discussion and Possible Action on an Ordinance by the City Council of the City Of Leon Valley, Texas Authorizing the Issuance of "City Of Leon Valley, Texas General Obligation Refunding Bonds, Series 2021"; Levying an Annual Ad Valorem Tax, Within the Limitations Prescribed by Law, for the Payment of the Bonds; Authorizing the Execution of Any Necessary Engagement Agreement with the City's Financial Advisors; Delegating the Authority to Certain Members of the City Council and City Staff to Execute Certain Documents Relating to the Sale of the Bonds; and Providing an Effective Date (M&C # 2021-03-09-04 A. Burger)

Anne Burger Entrekin, Regional Managing Director at Hilltop Securities presented the item seeking City Council consideration and approval of an ordinance authorizing the Issuance of "City of Leon Valley, Texas General Obligations Refunding Bonds, Series 2021" which will refund (refinance) the Public Property Finance Contractual Obligations, 2009 that was issued to purchase a ladder truck for the Fire Department and General Obligation Bonds, Series 2012 that were issued to fund construction and renovations for the police, fire and administration complex. Refunding of existing debt would save interest costs and thereby save the amount needed for annual debt payments.

Ms. Entrekin concluded the presentation by adding that state law does allow a City to adopt ordinances pertaining to bonds in one (1) read vs. two (2) reads which the City of Leon Valley Charter requires. This is pursuant to Section 1201.028, as amended, in the Texas Government Code.

A motion was made by Councilor Josh Stevens to move forward with accepting this perimeter bond sale for the refunding of the current debt that the City has that is callable; with the perimeters that you have outlined for consideration on our packet, page 145. The motion was seconded by Councilor Jed Hefner.

Councilor Josh Stevens withdrew his motion before a vote was taken, asking to do so in order to re-word the motion itself.

Councilor Josh Stevens motioned to adopt an ordinance authorizing the issuance of "City of Leon Valley, Texas General Obligation Refunding Bonds, Series 2021" pursuant to a delegated sale. The motion was seconded by Councilor Jed Hefner.

Presentation and Discussion on an Ordinance Amending Ordinance No. 2020-33, Providing Requirements for Citizens to be Heard Comments Submitted by the Public; and other Pertinent Amendments Desired by Members of City Council (1st Reading as Required by City Charter) (M&C # 2021-03-09-06 Mayor Chris Riley)

Mayor Chris Riley presented the item which was followed by a discussion.

Mayor Riley asked that all members of City Council submit their proposed amendments to the city secretary and for the item to be brought back to Council as a proposed ordinance.

Presentation and Discussion to Authorize the City Manager to Enter into an Agreement with Bexar County Accepting a Community Development Block Grant (CDBG) in the Amount of \$318,960 to Provide Funding for the Settlers Ridge Water and Sewer Main Project, Authorizing the Execution of the CDBG Program Agreement, and Approve an Ordinance Authorizing a FY 2020-2021 Enterprise Fund Budget Adjustment in the Amount of \$637,920. (1st Reading as Required by City Charter) (M&C # 2021-03-09-08 D. Dimaline)

Melinda Moritz, Public Works Directed presented the item seeking City Council consideration to authorize the City Manager to enter into a grant agreement with the Bexar County CDBG Department and approve an Ordinance authorizing a budget adjustment, in the amount of \$637,920, with 15% for contingency, from the Enterprise Fund Reserve. The Agreement is between Bexar County and City of Leon Valley and would provide project assistance funds in the amount of \$318,960 to be used for the Settlers Ridge Water and Sewer Main Replacement Project.

In March 2020, the City of Leon Valley submitted an application for consideration for the 2020 CDBG program. Individual meetings were held with participating cities to discuss their plans and to identify needs in their cities. The project will include the replacement of aging water and sewer mains along Settlers Ridge (Conestoga to Blacksmith). The project scope includes replacing 1380 feet of 6" asbestos-concrete water main with new C-900 pipe, replacing 1220 feet of 8" sewer main, re-connecting 40 service lines, installing 2 new gate valves, installing two new fire hydrants, replacing 4 sewer manholes and providing for asphalt repairs.

The grant application was evaluated to ensure the project met HUD guidelines. In August 2020, the Bexar County Commissioners made their final selection of projects and recommended partial funding for this project.
