Administration of the Oath of Office to Police Chief David Gonzalez (Mayor Chris Riley)

Mayor Riley administered the Oath of Office to David Gonzalez, Chief of Police.

Presentation and Discussion on an Ordinance Accepting Two Texas Office of the Governor (OOG) Grant Award and Adjusting and Increasing the General Fund Budget in the amount of \$31,322 for Ballistic Rifle Armor Carriers and an amount of \$38,032 for Training Equipment, for a Total Budget Adjustment of \$69,354 (1st Reading as required by City Charter) (M&C # 2021-03-15-01 D. Gonzalez)

David Gonzalez, Chief of Police presented this item with the assistance of Crystal Caldera, Acting City Manager who both explained to the City Council that this item was actually approved and adopted by City Council in November, but that there was an error. The error was a "clerical error" but it does need to be corrected before the department applies for the grant.

This item will be placed on the next City Council agenda for a second read and consideration.

Presentation, Discussion, and Action to Consider Approval of an Emergency Ordinance Authorizing a Budget Adjustment in the Amount of \$45,000 for Winter Storm Damage Repairs to the Huebner Well (1st Read as Required by City Charter) (M&C # 2021-03-15-02 M. Moritz)

Melinda Moritz, Public Works Director presented this item seeking City Council approval of an Emergency Ordinance authorizing a budget adjustment in the amount of \$45,000 for emergency repairs to the Huebner well, located at 7520 Huebner Road.

The winter storm that took place the week of February 13th - 20th, 2021 caused a chlorinator pump and line to break, an electrical relay component to freeze, and the Huebner well stem to shear in half.

In order to determine what repairs were needed, a contractor was called and they removed the well piping, pump, and broken portions of the assembly for inspection and then secured the site. They have now determined that the cause of the failure was due to the freezing of the electrical relay to the submerged pump, which caused the well shaft to pump without proper lubrication, causing the well stem to seize and break. We will receive a final report on the damages after the repairs are completed.

The City is currently operating on the Grass Hill well and will continue to do so until the Huebner well is repaired, disinfected, tested, and put back into service. We anticipate repairs to take approximately one week for completion, then disinfection and testing will

take place the following week. The contractor has already ordered the necessary parts and is waiting on delivery, which may take an additional week due to scarcity of sourcing.

Director Moritz concluded the presentation saying that the quoted cost for repairs is \$40,944.50; however, there are still some unknowns that may require additional hours above and beyond the 28 hours estimated for repairs at \$215 per hour. We will only be billed for actual additional hours worked.

The Ballistic Budget item is exactly the same as presented by salvaggio last year, there is still no explanation of what the \$38,032 for training equipment comprises of.

As with the vicious \$52,000 Long Range Audio Weapon which he insisted must be kept with the Leon Valley police even though all the rest of the equipment was going elsewhere, The Ballistic Carriers and mystery training equipment, seem as unnecessary as the gas masks and audio weapon, as mentioned previously, unless the police suspect that the Citizens of Leon Valley are starting a civil war, none of this equipment is necessary except in an offensive capacity, and it is very clear who Leon Valley police find offensive.
