Discussion and Possible Action on a Resolution Authorizing Staff to Adjust the Required Certificate of Occupancy Fees for the Updating of all Certificates of Occupancy at 5405 and 5504 Bandera Road (M&C # 2021-04-06-13 B. Melland)

Brandon Melland, Planning & Zoning Director presented on behalf of Robert Boe, President JFB Construction, LLC. Mr. Boe represents the owners of the properties located at 5504 and 5405 Bandera Road, which are Timco Bandera EPA LLC. and West Loop Distribution Center EPA LLC., respectively. Both are owned by the same holding company.

Director Melland went on to say that the owner recently acquired these properties. Due to

the underlying ownership of these properties having changed, the Zoning Code requires that the individual certificate of occupancy (CO) for each business be updated because each CO specifies the owner of the property, as directed by the International Building Code (IBC). Because the City is updating the CO, which represents a recertification by the City of Leon Valley that the facility is safe to occupy, the City must conduct inspections. Therefore, the process of updating a CO expends the same City resources as issuing a new CO, which generally includes an inspection by the building inspector and fire marshal. This process costs \$125 per CO. However, there are approximately 35 tenants within these two facilities combined. This would cost the property owners approximately \$4,500.

Director Melland stated that Mr. Boe feels that the fee is excessive and is requesting some form of relief from the fee.

Director Melland added that staff also believes that this is excessive for the following reasons: It is not necessary to inspect every suite in this instance because the fire marshal already conducts an annual inspection once a year to ensure International Fire Code (IFC) compliance; and an inspection by the building inspector is most necessary at the time a business opens; and a general inspection of each building, in this case, will be sufficient.

When I saw the agenda item on the topic of "Declaring intent to phase out red light cameras" I was bewildered. Why? These currently installed cameras are not illegal. But running a red light is most definitely illegal.

This system was put in as a result of the Citizens Police Advisory Committee and the former police chief's desire to reduce the number of red light-running incidents and associated wrecks. And you know what? It is working, despite the ridiculous claims by naysayers that it isn't.

The State of Texas, the camera system company, and the City of Leon Valley each receive a percentage of the fines collected. The portion of funds that Leon Valley receives can only be used for public safety-related expenses. It is not a money-making scheme to fill the city's coffers.

The resolution on this subject found in the agenda packet begins with; WHEREAS, The City Council of Leon Valley ("Council") believes the number one priority of Leon Valley City Government is to ensure the safety of its citizens and the public;

Phasing out red light cameras seems like the **opposite** of ensuring the safety of Leon Valley citizens and the public.

Furthermore, whomever authored this resolution accidentally on purpose left out an important fact. It should have read, "WHEREAS, Existing red light systems currently under contract are completely legal despite the passing of House Bill 1631;"

If you are unsure of this, check with State Representative Ray Lopez. He is familiar with the subject.

And some final thoughts, if you eliminate the camera system, what are you going to tell the parent of someone laid up in the hospital after their car was t-boned by a red light runner at Bandera and Seneca? How will you feel after a pedestrian crossing Grissom Road is run over by a driver rushing through a red light to turn left from Bandera?

Please think about public safety, not just what you want.

Dear Ms. Passalaigue, I am writing this letter to you on the evening of April 5, 2021. I would like this letter to be read at the Mayor and Council meeting on Tues. evening, April 6, 2021.

I have heard that two of the items on the agenda for the City Council are to remove the red light cameras and then to reduce the size of the Leon Valley Police force. Both of these issues are mis-guided at best. The red light cameras have brought in much needed revenue to the City in the form of fewer accidents, safer streets and additional officers on the streets. It's nice to see a police vehicle in the neighborhood on a regular basis now that the City has the manpower to do so. Prior to the added manpower, if I saw a police vehicle in Pavona Place I assumed the officer was lost. That's because they were seen so rarely. I have never heard a citizen of any city call to defund the police unless they were part of a group of protesters who were intent on protecting criminals. Listening to the rhetoric from around the country you would think the general consensus is to defund police depts. That is not the case. The vast majority of citizens like to know they can call 911 and get a response. If the police are defunded who do I call? The City Council? I'm sure they'll all come running. I have had trouble trying to contact LVPD on the non-emergency line, most recently during the power outage, ever since our 911 call center was moved to Bexar County. Some of the money from these red light cameras could be used to re-instate our call center so we can once again contact our own police.

Speaking of the red light cameras, the City has a long term contract, apparently some 20 years, with the company monitoring the cameras. At the current time these cameras cost the City nothing and bring in revenue which can only be used for public safety. That means that our Police Dept. can hire more officers to protect the citizens of Leon Valley, update their equipment, have better radio communication, and, essentially protect the residents of Leon Valley and themselves. Reducing LVPD manpower puts our officers lives in even more danger than they already face daily. The revenue from the traffic cameras means our police don't have to depend on San Antonio for back up, which could take too much time and get our officers injured or killed. To me, as a retired police sergeant, this is not acceptable.

Another consideration is how much would breaking this lengthy contract cost the taxpayers of Leon Valley? Because I know the money to break this contract

is not coming out of the pockets of the City Council. Everything they do or spend money on has a direct effect on the City taxpayers. As I recall, when the red light cameras were contracted for, the City Council was all for it. If they get some complaints from LV residents about the fines as I have read on the Next Door website, those residents should be informed that they should have stopped for the red light. If you stop, you don't get a summons. It's that simple. The red light is not a suggestion, it is the law. It seems though, that the vast majority of summonses are sent to people driving through Leon Valley in a hurry to get home after work.

So in closing, from my point of view, the red light cameras are all upside. It would be, to put it politely, non-sensical to remove them.


