Discussion and Possible Action on a Resolution Granting a Variance to Section 3.05.005 of the City of Leon Valley Code of Ordinances to Allow for an 8-Foot-Tall Fence in the Side and Rear Yard at 6703 Forest Haven Street, Generally Located on the North Side of Forest Haven Street at Forest Leaf Street (As Requested by Councilor Josh Stevens and Councilor Jed Hefner) (M&C # 2021-06-15-05 Councilor Josh Stevens and Councilor Jed Hefner)

Mayor Chris Riley introduced this item and then explained her position on it. Mayor Riley concluded by making a suggestion to members of City Council that an item be added to the July 24th Coffee with the Mayor & City Council to discuss this issue further.

Councilor Josh Stevens read an e-mail submitted by: Dr. Jay Chaudhuri (applicant)

Councilor Benny Martinez read a statement he had prepared which included a suggestion to "table this item for ninety (90) days while City Council reviews and possibly makes changes to allow 8-foot fences with some regulations and/or requirements. I also recommend any enforcement action be stopped while we address this matter."

A motion was made by Councilor Will Bradshaw to approve the variance. The motion was seconded by Councilor Jed Hefner.

Discussion and Direction to Staff Regarding Amendments to Chapter 3, Building Code and Chapter 15, Code Regarding Residential Fence Height, Special Exceptions for Fence Height, and the Responsibility of Multi-Family Uses and Commercial Uses to Construct Vision-Proof Fences when Adjacent to One Another (As Requested by Councilor Josh Stevens and Councilor Jed Hefner) (M&C # 2021-06-15-18 Councilor Josh Stevens and Councilor Jed Hefner)

Brandon Melland, Planning & Zoning Director presented the item to receive Council feedback regarding the following three topics: 1. As previously directed by Council, Exhibit A proposes to amend Section 3.05.005(a) Residential Fences, to allow private property owners to construct up to 8-foot-tall fences between two pieces of privately owned property, as long as: a. The private property owner obtains written consent from the property owner(s) abutting the edge(s) of the property where the taller fence is to be placed; and b. Fences taller than 6 feet are not facing a public street made of asphalt unless a variance or special exception is granted.

Director Melland added that staff seeks Council direction regarding the responsibility of Multi-Family Uses and Commercial Uses to construct vision-proof fences when adjacent to one another.

Director Melland concluded by saying that Council previously proposed to amend Section 15.02.722 (s) of the City's Zoning Code to establish a process for granting special exceptions for fence height under specific circumstances.

Councilor Josh Stevens gave a presentation of the results of a survey he conducted on social media where eighty-seven (87) people responded. Councilor Steven's presentation covered proposed options such as a Special Exception which would: have a lower threshold; special circumstances in lieu of variances; could have a simple, streamlined process; could go before the Board of Adjustment or the City Council; could have a criterion as simple or as complex as the City Council wants; could require 8-foot fences be constructed of another material such as half stone, half concrete border; and could require 8-foot fences blend in to 6-foot fences if requested on arterial roadways.

Councilor Stevens also proposed an EZ Exception for fences that are not facing a public (asphalt) street; for fences that are less than 15-feet long and not facing a public arterial roadway; could be a simple, streamlined process that can all be done online; would be administratively approved with no discretion (either you meet criteria or you not); and would require signature forms or affidavits from all abutting property owners.

Following a brief discussion, staff was given direction to bring back a draft ordinance for a first and second read but to also place a discussion item on the Coffee with the Mayor & Council Agenda to get citizen input.

Discussion and Possible Action on an Ordinance Granting a Specific Use Permit for Temporary Placement and Occupancy of a Recreational Vehicle During Renovation and Construction of the Permanent Residence on the Property at 7710 Stebbins; Generally Located at the Southeast Corner of Stebbins Drive and Thunderbird Lane; and a Public Hearing on Said Request (1st Reading was Held on 06-15-2021) (M&C # 2021-07-07-___ B. Melland)

Brandon Melland, Planning & Zoning Director presented on behalf of the applicant who recently purchased the property and is planning to renovate the existing residence. In order to conserve money during the construction for housing expenses, the applicant would like to place and occupy their recreational vehicle on the property during construction. The City's zoning code classifies such an activity as a temporary land use and assigns the Specific Use Permit (SUP) process for such approval. Therefore, the applicants are requesting approval of an SUP.

Presentation and Discussion Regarding Potential Amendments to Article 3.04, Sign Code of The City of Leon Valley Code of Ordinances; as Recommended by the Sign Code Update Advisory Committee (M&C # 2021-06-15-06 B. Melland)

Brandon Melland, Planning & Zoning Director presented this item at the request of Councilor Rey Orozco who wanted an update on the potential amendments to Article 3.04, Signage, of the City's Building Code.

Director Melland recalled that last year the City Council established the Sign Code Update Advisory Committee to consider amendments to the City's existing signage regulations. These amendments and the committee were originally initiated due to citizen complaints regarding temporary signage and political signage.

There was a lengthy discussion.

There was a consensus among members of City Council to have Councilors Orozco and Hefner work with Director Melland with input from business owners to draft an amendment to be brought back to City Council at a later date.

Councilor Rey Orozco called a Point of Order.

Discussion and Possible Action on a Resolution Authorizing the Northwest Little League to Reconstruct a Sign on the City Owned Property at 6916 Poss Road (M&C # 2021-07-07-__ B. Melland)

Brandon Melland, Planning & Zoning Director presented this item for the City Council to approve a resolution authorizing the Northwest Little League (NWLL) to Reconstruct a Directional Sign at the corner of Poss Road and Andres Salazar Road.

The original sign was constructed in the early 1960's, but was recently demolished by a vehicle. The NWLL now wishes to reconstruct the sign as illustrated in the attached power point. However, Andres Salazar is located on City owned property, which requires Council authorization and potential legal agreement due to liability issues.

Councilor Benny Martinez suggested having a Memorandum of Understanding (MOU) drawn up between the Northwest Little League and the City of Leon Valley.

City Attorney Roxana Stevens said she would need to do a legal review on the survey results and suggested tabling the item to the next meeting.

Discussion and Direction to Change Our Permitted Use Table to Allow Religious Type Facilities In "Nearly All" Zoning Districts (M&C # 2021-06-15-07 Councilor Josh Stevens and Councilor Will Bradshaw)

Councilor Josh Stevens presented saying that he does "not think there is an option but something we, as a governing body has to do. We need to change our laws in some form or fashion to both comply with the Texas Supreme Courts and with what the Federal Courts have said." Councilor Stevens concluded his presentation saying the "simple solution is to change the Permitted Use Table to allow churches and religious type facilities in all or almost all zoning areas, including residential areas."

There was a lengthy discussion on this item.

City Attorney Roxana Stevens will conduct some research to see if the City is required to allow religious institutions in all residential areas as she works with Director Melland; and then they will bring something back to the Planning & Zoning Commission to review before coming back to City Council with a recommendation.

Presentation and Discussion to Amend Chapter 1 "General Provisions, Article 1.06 Boards, Commissions, and Committees", Section 1.06.03, "Capital Facilities Oversight Committee", Number 4. b) to Allow the Committee Members to Meet to Investigate Capital Improvements Projects that are Located Outside the Leon Valley City Limits (1st Read as Required by City Charter). (M&C # 2021-06-15-16 M. Moritz)

Crystal Caldera, Acting City Manager presented the item for the purpose of this item is to revise Section 4. b) of the recently created Capital Facilities Oversight Committee (CFOC) Ordinance that states "All Committee meetings shall be held within the City of Leon Valley geographical boundaries.", to allow the Committee to meet outside the city limits for the purpose of investigating other like facilities. The Committee would like to visit the City of Kyle, City of New Braunfels, the City of San Antonio, and other places to see new facilities and ask how they operate and find out what the owners of such facilities think could have been done differently, and if any other obstacles or opportunities came about as a product of the design. The current Ordinance prohibits them meeting as a group at these facilities. While subcommittees within the Committee are expected, they may wish to meet as a whole at one or more of these facilities.

ACM Caldera concluded the presentation saying that the new language would state: "4. b) Committee meetings shall generally be held within the City of Leon Valley's geographical boundaries, but meetings may take place outside the City boundaries after proper posting of an agenda, with the place, date, and time of meeting."

A couple years ago we had a real battle concerning the request brought by St John Baptist Church to rezone their property (on Huebner at Evers) to B-2 and/or B-3 zoning.

The owners of the 3 surrounding residential neighborhoods, zoned R-1 and R-6, petitioned to deny the change in zoning. The uses allowed in B2 and B3 by right are extremely intense and incompatible with the surrounding residential uses. . The zoning change to B-2 or B-3 is also not compatible with the Leon Valley master plan

The Leon Valley property owners representing the surrounding 3 neighborhoods had/have no issue with a potential rezone of the St Johns property to other transitional R districts i.e. apartments, 2 plex, or four plex residential and allowing a church to be built on land thus rezoned.

The Church, to my knowledge, has not chosen to rezone to an "R" zone compatible to the surrounding residential uses and the building of a church.

The president of the Pavona Place HOA, Elaine Valdez, has been actively promoting on behalf of the church. It should be understood she is acting in her personal interest and is not speaking on behalf of the Pavona Place HOA members.

Dear Mayor Riley and Councilmen,

Recently, I watched a video of James Springer collecting his property from the Leon Valley Police Department. He was an individual scooped up by Joe Salvaggio's press conference, mass arrest. It seemed to me, as I watched James finally retrieve family photos, personal vids, and lost work, that LVPD was finally owning their mistakes and moving beyond Joe Salvaggio. It felt as though the world is righted from it's wobbling spin, and we can all move along with life. Then it dawned upon me, about a month before his dismissal, Joe Salvaggio presented to Council property room fees and their justification. He stood there and assured Council, and the citizens, the fee IS discretionary, rarely used, and would never be used against victims or those wrongfully charged.

I noticed that the City of Leon Valley had the audacity to charge James a \$25 per incident, both happened as a result of a single arrest, to receive his property. I believe the total fees were over \$55. Please note, all charges were dropped, no conviction as none of the charges even made it to a hearing, as the DA dismissed the cases for "lack of evidence of a crime." I think it's important to state, the man went without his property for almost three years and didn't receive all of it back, as the LVPD decided to dispose of two items. I understand Joe Salvaggio claimed more charges pending but, it's clear to anyone who's read the depositions, warrant applications, and courts denial of said warrants, of the Federal lawsuit, that pipe dream evaporated about a year and half ago. LVPD also charged fees to Jack Miller, David Warren, and probably all the rest of the people who were falsely arrested by the LVPD, due to the misconduct of Joe Salvaggio.

I do understand returning their property is lawful and the ethical result, but should have taken place much sooner, as we probably all agree. However, charging people for their property, they were denied, is not only spiteful, it's the reason people do not respect police or many municipalities across this nation. This cannot be the new normal of municipal governance OR even considered lawful for police to confiscate property, hold property, and then charge the owner for the misconduct, or honest mistake, of a governmental organization.

But, believe it or not, that's not my point. My point is Chief Gonzalez didn't understand, when James made a comment referring to the fee and time his property was unlawfully held by LV, as he stated, "Well, it will only hurt the City more.... It will cost the City more." To which Mr. Gonzalez stated, "It wouldn't," and looked at James as though he were crazy and asked, "How?".

Being a principal of business for 15 years, I was stunned. How does anyone, in a management position, not understand limiting organizational risk? What Mr. Gonzalez stated is the very philosophy that creates disconnect of government agencies between citizens: Cost of harm to citizens is not a concern since the taxpayer is the unlimited source of settlement. It is the very thing that resulted in Joe Salvaggio's termination: Joe didn't misconduct by the police results in potential cost to the City financially and by reputation.

But further, as famously stated by Kelly Kuenstler, "We have insurance for that," when speaking of claims made due to police misconduct, isn't a solution to this problem. Sorry Leon Valley, that doesn't eliminate the need of best practices, risk management, human resources screening of officers, training, or the ethics of the department. Mr. Gonzalez seems not to understand misconduct resulting in potential loss to the City he's supposed to serve. You all do understand how insurance and surety works, I hope? Lawsuits of this nature do not help surety or underwriting rates.

Removing Joe didn't solve the underlying problem of this department. Being polite and smiling, as the LVPD continues to engage in unethical behavior, isn't change. A lack of basic understanding that a police department is a cog in the machine of a business (the city) is unbelievable. The departments actions have financial impact upon the city. A chief of police who doesn't understand that simple fact does not belong in leadership.

I hope Leon Valley entertains contracting with another agency rather than maintaining or downsizing the dysfunction that is the Leon Valley PD. Bexar County or San Antonio would save the City a fortune compared to lawsuits, tarnished city reputation, citizen frustration and confidence of the LVPD. It's just sad.

So sorry council and the mayor were ever duped into that city charter and the previous council was filled with those who allowed Joe and Kelly to run your City. What a disaster..... Movies will be made.

Dear City Council of Leon Valley

Thank you Mayor Riley and all for putting my fence issue as first issue to be discussed at the meeting tomorrow. I greatly appreciate your flexibility in this, unfortunately I will not be able to attend the meeting tomorrow at 6 pm due to work obligations. I feel I already made my points at the first meeting and nothing has changed in my opinion. I would like to outline and reiterate a few of the obvious reasons I should be allowed to keep the 8 feet fence.

- 1. It does not cause the city to lose aesthetic beauty. In fact the few people arguing against the fence described it as beautiful many times at the meeting. It was very counterintuitive to me why they wanted it cut.
- 2. It replaced a 40 year old dilapidated chain link fence. I don't feel like I should be punished for improving the appearance of our neighborhood. The cost of a 8 feet fence was \$5000 more compared to 6 feet fence.
- 3. Precedents were set by past approvals of 8 feet fence. My fence is no different from other cases that were approved before me. In fact I argue my fence satisfies same issues and more from prior cases. I have one of the largest slopes in the city. From the back of property to front of property the slope requires larger fence to help with privacy. The same reason prior 8 feet fence was allowed for another citizen. Again I am no different from other citizens. We are all equals regardless of income, race, ethnic

background or any other differences we might have.

- 4. A few times in last weeks meeting comments were made that it would be easy for me to cut the fence. Nothing could be further from the truth. I would not be cutting a 5 yard stretch, I would have to cut over 100 yard of fencing. Cutting would be straight across the top eliminating the beautiful beveled edges of the fence. No contractor can cut bevel edges by saw. It is done by machines at factories. Thus we would create an "Ugly structure" for the city and neighborhood.
- 5. Home Owners and people's rights as citizens. It is a slippery soap to impose the will of the city by forcing an ordinance on a citizen that is clearly outdated. Councilman that voted against my 8 feet fence stated after the vote he would support new ordinance to allow for 8 feet fence. I was perplexed by his actions but supported his thoughts nonetheless.
- 6. The city has wasted enough tax payor dollars fighting cases like this before. This is a great little city that does not need to waste its citizen's time or hard earned dollars fighting its citizens. No one wins at the end with litigation only the lawyers.

Again, great thanks to Mayor Riley and all Councilmen for allowing me to be heard and putting my case at the top to allow me to go back to work early. I know all of you do the work you do as a volunteers for the city. I greatly appreciate the sacrifice you all make for the city and it's citizens doing the job that you do. I hope you reconsider my situation and decide on a fair outcome for all. Thank you for your time. Hoping for the best tomorrow.

Good evening Mayor Riley and Councilors,

On the topic of fence heights, I would like to impart some knowledge garnered by decades of experience in animal rescue. As most know, the nextdoor app has a prolific amount of lost dogs posted. A good many of those dogs are Huskies and German Shepherds.

These breeds of dogs need a job to do, otherwise they look to make their own kind of fun. Usually this involves their native ability to easily clear a 6 foot fence in their search for adventure. If pet owners were allowed to have an 8 foot fence they would then be able to safely secure their animals as well as their home. Not many people can look over an 8 ft fence!

Having this height of fence could certainly free up the ACO and other members of the Leon Valley Police, allowing them to turn their attention to other city concerns. Also this would reduce the safety concerns of the citizens from roaming dogs.

My final comment for your consideration , rescues utilise an 8 ft fence as a secure way of containing their dogs. So for the safety of the citizens, the dogs and the families that love them, I ask you to amend the 6 ft to an 8 ft height of the fences in chapter 15, of the Leon Valley code.

Dear Mayor Riley and Councilors:

One of the foundational principles of American governance is the right of the governed to elect peers so that the people may be fairly represented. Rather than a monarch, military dictator, or a single influential do-gooder running the city, the residents have elected councilors.

I was disappointed to learn that the Mayor exercised her authority to break a tie and voted against the position of an absent councilor. I was confused why the mayor would make such a strong political stand, especially since registering a negative vote did not change the outcome.

While the actions were technically legal, it was against the spirit of democracy. It was against what we stand for as Americans. And it's probably not the outcome that would occur with all members present.

Not too long ago, Leon Valley was disrupted by an unelected city staffer who did whatever she wanted, despite the will of the people. We cannot allow tyranny to repeat itself. The leaders of Leon Valley should remember that they are simply a vote at the table. Through these votes, the will of the people is enacted into city policy. It's not a perfect system, but it's better than having no voice at all. However, when those in power use special circumstances to cleverly get what they want--even when it's not the majority position of all elected leaders--it corrupts the council and erodes trust in government.

For those who voted against the reasonable request to build a suitable fence, please put yourself in the resident's shoes. How would you like it if the city made you reduce the height of your radio antenna? What if your employer was unable to put up a tall sign--would you still have as many people visit the car lot? How many of you placed political signs up on others' fences?

Why isn't the fence variance on the agenda for tonight? Are there even more games being played to block a full vote on this matter?

Please discuss placing this item on the agenda--or the reasons for why it is not on the agenda. It is my understanding that such discussion is specifically permitted by state statute.
