Mayor Chris Riley welcomed everyone and then announced a quorum of City Council was present.

Mayor Riley led the Pledge of Allegiance. Mayor Riley welcomed new City Manager Gilbert Perales.

Gilbert Perales, City Manager thanked the Mayor and Council for their trust and told the public that he was really excited to be here and looks forward to working together to improve wherever improvement can be made.

#### SPECIAL BUDGET WORKSHOP

Mayor Chris Riley read the ordinance caption for the first read as required by City Charter.

Crystal Caldera, ACM/HR Director presented the proposed Fiscal Year 2022 Budget for the workshop.

Mayor Chris Riley requested a separate item be placed on the next City Council agenda to discuss phasing out the Impound Lot.

Direction was given to the LVFD Chief to move forward with what is currently budgeted to find a truck as requested.

The proposed budget presentation will continue at the July 20, 2021 meeting and will be presented again at the July 24, 2021 Coffee with the Mayor & City Council.

Mayor Riley took this opportunity to briefly go over the Rules of Decorum.

#### OLD BUSINESS

Presentation, Discussion, and Possible Action on a Resolution Authorizing the City Manager to Enter into a Contract for Banking Services with Frost Bank to serve as the Depository for the City of Leon Valley from October 1, 2021 to September 30, 2026 (M&C # 2021-07-07-02 F. Messick)

Floyd Messick, Assistant Finance Director presented this item seeking City Council approval of a resolution authorizing the City Manager to enter into a contract for banking services with Frost Bank to serve as the depository for the City of Leon Valley. The term of the contract is October 1, 2021 to September 30, 2026.

In March, the City solicited Request for Proposals (RFP) for depository services. The only two banks to submit a proposal were Truist Bank and Frost Bank.

Assistant Director Messick concluded the presentation saying that staff recommends the approval of the resolution authorizing the City Manager to enter into a contract for banking services with Frost Bank to serve as the depository for the City of Leon Valley for a term of five years from October 1, 2021 to September 30, 2026.

Councilor Jed Hefner requested that a future agenda item be placed on the agenda to discuss the City's Investment Policy.

ACM/HR Director Crystal Caldera replied to Councilor Hefner that the Investment Policy comes to City Council every October for review and that to her knowledge, Finance Director Vickie Wallace has sent that to each member of Council. ACM/HR Director Caldera asked that each member of City Council review the policy and send her questions they may have before the item comes to them in October.

Councilor Jed Hefner responded that he would take a pass at it but if he had questions that he would bring items forward that he wants to discuss before October.

Discussion and Possible Action on a Request by Adolfo Garza for a Zone Change from B-2, Retail District Zoning with Sustainability Overlay District Zoning, to PD, Planned Development District Zoning with B-2, Retail District Zoning and Sustainability Overlay District Zoning at 6617 Evers Road; Generally Located on the East Side of Evers Road, approximately 400 feet South of Huebner Road; and a Public Hearing on Said Request (1st Read was Held on 07-07-2021) (M&C # 2021-07-20-03 B. Melland)

Brandon Melland, Planning & Zoning Director presented this item on behalf of the applicants who are the owners of Paradise Total Auto Care. The facility is located at 6617 Evers Road, just west of the Canterfield Subdivision. The facility consists of a traditional self-service car wash with several bays, several pop-up canopies for auto detailing, and two buildings.

Director Melland added that the Planning & Zoning Commission recommended approval at their April 13, 2021 subject to Staff's recommended conditions which are: 1. That the use and development of the property shall be subject to a base zoning of B-2, Retail District and SO, Sustainability Overlay District; 2. In addition to the use standards of the B-2 District and the SO District, the property may also be used as a self-service and full-service car

wash, including auto-detailing; 3. Notwithstanding the requirements of the B-2 Retail District, the property shall be developed in accordance with the site/landscaping plan submitted; 4. That the existing pole sign on the site be removed; 5. Outside storage of equipment, supplies, or customer vehicles shall not be permitted outside of normal business hours; 6. Business hours shall be limited to between 6:00 am and 9:00 pm, Monday through Sunday; and 7. No vehicles may be parked of-site.

Director Melland said he would need to get a Public Utility Easement (PUE) as this lot was platted a while back.

Brandon Melland, Planning & Zoning Director presented this item This purpose of this item is to consider amendments to Chapter 15 of the City's Code, which is the Zoning Code. The specific amendments are with regard to allowing churches, by right, in all residential and nonresidential zoning districts.

Director Melland added that this amendment is being considered at the request of Councilors Josh Stevens and Will Bradshaw.

Director Melland concluded the presentation saying that the Planning & Zoning Commission recommended that the Code not be amended on a vote of 5 to 1 with Commissioner Rowse voting for the code amendment.

City Attorney Roxana Stevens informed members of City Council that if the City Council chooses to overrule the Planning & Zoning's recommendation, that would require a super majority vote.

Councilor Josh Stevens announced that he received an e-mail from the Planning & Zoning Chair, Ed Alonzo saying "that had he known what he learned after the meeting, it may have changed his vote and one of the other voting members of the Zoning Committee that he talked to because he didn't realize that there was universal church zoning in all of these areas around San Antonio."

Councilor Josh Stevens stated that he has read the opinion and disagreed with the city attorneys on this issue.

Councilor Rey Orozco wanted to know why Planning & Zoning Commission Chair Alonzo

didn't share the e-mail he sent Councilor Josh Stevens with the members of the Planning & Zoning Commission or members of City Council.

Councilor Josh Stevens asked City Attorney Roxana Stevens about the super majority vote and where this came from.

City Attorney Roxana Stevens replied that this could be found in Chapter 211 with regard to the requirements on zoning under the Texas Local Government Code. City Attorney Stevens explained that if the City Council chooses to accept the Zoning Commissions recommendation, that would require just a simple majority; but if they choose to overrule it, that would require a 75% or a super majority vote (4 out of 5).

City Manager Gilbert Perales reminded everyone that even if a church moves into a strip center, it will only effects sales tax, not property tax.

Discussion and Action to Consider Approval of a Resolution Awarding a Bid in the Amount of \$521,514.32, with 15% for Contingency, and Authorizing the City Manager to Enter into a Contract with EZ Bel Construction for the Construction of Water and Sewer Improvements on Settlers Ridge (M&C # 2021-07-07-19 D. Dimaline)

David Dimaline, Assistant Public Works Director presented this item seeking City Council consideration of a resolution awarding a bid in the amount of \$521,514.32 and authorizing the City Manager to enter into a contract with EZ Bel Construction for the purpose of constructing water and sewer improvements on Settlers Ridge.

Assistant Director Dimaline gave a brief background saying that the City of Leon Valley submitted an application for consideration for Bexar County's 2020 Community Development Block Grant (CDBG) program. The project will include the replacement of aging water and sewer mains along Settlers Ridge. The project scope of work includes replacing 1380 feet of 6" asbestos-concrete water main with new C-900 pipe, 1220 feet of 8" sewer main, re-connecting 40 service lines, installing 2 new gate valves, two new fire hydrants, 4 new sewer manholes, and providing for asphalt repairs. In March 2020, the City Council accepted a Community Development Block Grant (CDBG) in the amount of \$318,960, authorized the City Manager to negotiate and execute a CDBG Program Agreement with Bexar County, and authorized a budget adjustment in the amount of \$637,920 to be used for the Settlers Ridge Water and Sewer Main Project

Assistant Director Dimaline concluded the presentation saying that staff recommends that City Council approve a Resolution accepting a bid in the amount of \$521,514.32 and authorize the City Manager to enter into a contract with EZ Bel Construction for the construction of water and sewer mains on Settlers Ridge.

Hi Mr. Cox,

I'm happy to hear that the City of Leon Valley is interested to hear from business owners and help us succeed or at least survive, under the current difficult business environment which has been affected by the COVID 19 pandemia. In particular, my multifamily business has been affected by the following:

1. Eviction hold over and certain tenants who have been taking advantage of it by not paying their rent and accumulating up to 17 months of past due rent. These tenants work and have income; therefore, they do not qualify or do not apply for rental assistance programs. We have several units that have not paid rent nor utilities and trash pick up since January 2020.

- 2. Lack and increase in price of contract labor. It's extremely difficult to find maintenance, janitorial, painters and other subcontractors. Prices have drastically increased for these services.
- 3. High Inflation in operating expenses such as utilities, insurance, property taxes, repair supplies, labor, wages, etc.

4. Increase of direct new competion in the neighborhood which has result in an increase of concessions or move in specials.

All the above factors have drastically affected the operating revenues. Although, I'm aware that the city can not do anything about these matters.

Specifically, I would love if the City of Leon Valley could help my business by:

1. Allowing the installation of balloons within the property fence line of my properties. This would improve the curb appeal and allow to increase the visibility of the entrance of the apartment communities to attract new prospects.

2. Providing long term banner permits to allow the installation of 1 front banner per property to advertise the monthly specials.
