  1. A Special Meeting of The City Council Is Scheduled for October 5, 2020, at 6:00 P.M. For the Purpose of Conducting A Hearing Pursuant to Home Rule Charter, Section 3.12 And City Ordinance, Section 1.04.006, Concerning Councilor Will Bradshaw's Asserted Violations of Home Rule Charter, Section 3.09 (B) And/or (C), And/or City Ordinance, Section 1.12.011 Stemming from His Encounter with Police Officers on About June 5, 2020. The City Council May Make Findings Regarding the Alleged Misconduct, And Also Recommend, Consider and Vote on Any Discipline That May Be Awarded to Councilor Bradshaw For Any Violations Found to Have Occurred. The Council May Conduct One Or More Closed Executive Sessions as Necessary to Confer with Its Attorney to Obtain Legal Advice Relating to the 3.12 Hearing, Findings, And Action by The City Council.

**Executive Session.** The City Council of the City of Leon Valley reserves the right to adjourn into Executive Session at any time during the course of this meeting to discuss any of the matters listed on the posted agenda, above, as authorized by the Texas Government Code, Sections 551.071 (consultation with attorney), 551.072 (deliberations about real property), 551.073 (deliberations about gifts and donations), 551.074 (personnel matters), 551.076 (deliberations about security devices), and 551.087 (economic development).

**Sec. 551.0411. MEETING NOTICE REQUIREMENTS IN CERTAIN CIRCUMSTANCES:** (a) Section 551.041 does not require a governmental body that recesses an open meeting to the following regular business day to post notice of the continued meeting if the action is taken in good faith and not to circumvent this chapter. If an open meeting is continued to the following regular business day and, on that following day, the governmental body continues the meeting to another day, the governmental body must give written notice as required by this subchapter of the meeting continued to that other day.

**Attendance by Other Elected or Appointed Officials:** It is anticipated that members other City boards, commissions and/or committees may attend the open meeting in numbers that may constitute a quorum. Notice is hereby given that the meeting, to the extent required by law, is also noticed as a meeting of any other boards, commissions and/or committees of the City, whose members may be in attendance in numbers constituting a quorum. These members of other City boards, commissions, and/or committees may not deliberate or take action on items listed on the agenda. [Attorney General Opinion – No. GA-0957 (2012)].
