City Manager Kelly Kuenstler reminded everyone that the City Manager's Report is posted on the website as well as placed on the table in the foyer for all interested. City Manager Kuenstler then supplemented that report with new information with: A) Demand letter for liquidation damages to EZ Bell Construction was received; B) Planning & Zoning Director Brandon Melland will now become the new floodplain administrator for the City of Leon Valley; C) Our office received notice today that the proposed FY 2018-2019 City of San Antonio Budget includes a \$600,000 line item for a corridor study of Bandera Road; and D) Our insurance rates are finally in and we came in at a 9.5% increase which will result in a savings of \$62,765.17.

Discussion and Action to Consider an Ordinance Approving and Adopting Fiscal Year 2019 Budgets and Associated Capital Acquisition Plans. (1st Read was Held on 07-17-2018) (M&C # 2018-08-21-09 K. Kuenstler)

Discussion and Possible Action of an Ordinance Ratifying the Fiscal Year 2019 Budget that will Raise More Total Property Taxes than Last Year's Budget by \$411,000 or 10.538%, and of that Amount \$74,239.47 is Tax Revenue to be raised from New Property Added to the Roll this Year. (1st Read was held on 07-17-2018) (M&C # 2018-08-21-10 V. Wallace)

A motion was made by Councilor David Jordan and seconded by Councilor Monica Alcocer to adopt the Ordinance ratifying the fiscal year 2019 budget that will raise more total property taxes than last year's budget by \$411,000 or 10.538% and of that amount \$74,239.47 is tax revenue to be raised from new property added to the roll this year.

Assistant Public Works Director David Dimaline presented the item seeking City Council approval of an ordinance dissolving the Stormwater Committee; and amending Chapter 14 Utilities, Article 14.09 Stormwater Management Utility, in Division 1. Generally, Section 14.09.004 Authority, to correct the state statute reference and Section 14.09.010 Stormwater Drainage Revenue Bonds, to correct the statute reference; in Division 2. Funding, Section 14.09.052 Stormwater Management Fund Established, to remove the reference to a board and in Section 14.09.057 Exemptions from Fee (a) and (b), to add language that would exempt school districts from paying the fees.
