

Leon Valley Park Commission Meeting Minutes

The Park Commission of the City of Leon Valley, Texas met on the 13th day of September, 2018, at 6:30 p.m., at the Leon Valley Conference Center, 6421 Evers Road, Leon Valley, Texas, for the purpose of the following business, to-wit:

1. Call to Order, Pledge of Allegiance, and Determine if Quorum is Present.

Chairman Christensen called the meeting to order at 6:30 pm, with the following Commissioners in attendance: Vice-Chairwoman Bolton, Commissioners Belinda Ealy, Linda Tarin, Kathy Hill, Carolyn Gabriel, Jack Dean, new Commissioner Michelle Alonzo, and new Alternate Commissioner Kris Ericson-Cano. Absent and excused were Commissioners David Smith and Geraldine Rodriguez-Smith. Also present were Staff member Melinda Moritz and City Council member Monica Alcocer. Chairman Christensen introduced the new members and then asked each Commissioner to tell a little bit about themselves and why they chose to be on the Park Commission.

2. Review and Consider Approval of the August 9, 2018 Regular Park Commission Meeting Minutes.

Commissioner Hill noted that her name was not listed as present. Commissioner Dean made a motion to approve the August 9, 2018 Park Commission meeting minutes, with the correction, which was seconded by Commissioner Hill. The motion carried unanimously.

3. Citizens to be Heard

There were no citizens in attendance.

4. Reports: Activities or Events that Impact Parks or Access to Parks:

A. Discussion and Action – The Ridge at Leon Valley Park Plan (M. Moritz).

Staff member Moritz gave the Commissioners a map of the proposed development plan for the Ridge at Leon Valley Park, noting that the outdoor fitness equipment was already installed and that the walking trail was under construction. She went on to explain that a playground would be installed in the

Commissioner Ealy stated that she had been to Magnolia House and had noticed the beautiful landscaping, rock boulders, and a patio area with permeable gravel surface. She then thanked the Park Crew for keeping the park looking so nice. She then stated that she was glad the new Evers Road bridge had lights in the columns

Commissioner Ericson-Cano noted that someone had made mention of wanting a dog park.

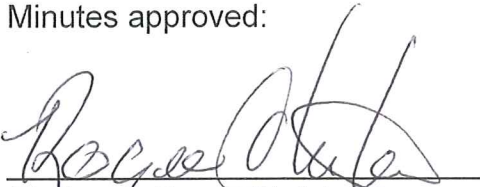
